# **Criteria for the Secretary of State's Award for Corporate Excellence**

Nominations are based on companies' achievements in one or more areas. A selection committee comprised of senior Department of State and other governmental officials and chaired by the Under Secretary for Economic, Business, and Agricultural Affairs, makes its determination of each year's winners based on the following criteria:

- Good Corporate Citizenship
- Exemplary Employment Practices
- Provision for a Safe and Healthy Workplace
- Responsible Environmental Protection and Practices
- Contribution to Overall Growth and Development of the Local Economy
- Compatibility/Contribution to Local Science and Technology
- Compliance with U.S., International, and Local Laws

#### **The Nomination Process**

The call for nominations is made each spring. Nominations are submitted by Chiefs of Missions at U.S. Embassies and Consulates abroad. Eligibility requirements include the following:

- 1) Nominated firms must be American (having headquarters in the U.S.);
- 2) Each firm must have been operating in the host country/economy for at least one year;
- 3) The activity for which a firm is nominated must have been in place for at least one year.

It is our hope that the successful model for economic development that we have demonstrated with FIJI Water will encourage additional responsible investment in the country that will bring about economic growth, and both educational and cultural opportunities that will positively impact the lives of the Fijian people for generations to come.
