Notice Regarding Initiation of 2008 Annual GSP Product and Country Eligibility Practices Review

In a Federal Register Notice, USTR announced that it will receive petitions in 2008 to modify the list of products that are eligible for **duty-free treatment under the GSP** program, and to modify the GSP status of certain GSP beneficiary developing countries because of country practices. This notice further determines that the deadline for submission of product petitions, other than those requesting competitive need limitation (CNL) waivers, and country practice petitions for the 2008 Annual GSP Product and Country Eligibility Practices Review is 5:00 p.m., Wednesday, June 18, 2008. The deadline for submission of product petitions requesting CNL waivers is 5:00 p.m., November 13, 2008. The list of product petitions and country practice petitions accepted for review will be announced in the Federal Register at later dates.
