OFFICIAL RULING ON THE AUTOMATED **EXPORT SYSTEM (AES) FILING**

The USDOC's Census Bureau has issued its final rule amending its regulations to implement provisions regarding filing of Shipper's Export Declarations (SEDs). The Census Bureau is requiring MANDATORY filing of export information using the Automated Export System (AES) or AESDirect for all shipments where the SED is required. This will take effect July 2, 2008.

There will be a 90 day implementation grace period where enforcement will not result in a penalty. In addition, the required citation of the ITN is to be noted and supplied to carriers (the XTN will not be acceptable proof of filing). Authorized exemptions and Post Departure Citation (Option 4) will continue to be accepted. After the grace period, penalties will immediately be enforced beginning at \$10,000 per transaction. It is the exporter of record's responsibility that the proper filing is done and that the ITN is on shipping

The term SED is to be immediately replaced with Electronic Export Information (EEI).
