

GSA awarded a contract for a fleet services card that will enable Federal fleets to cut costs and run a more efficient fleet operation. Wright Express Corporation, a pioneer and leader in point of sale technology, is the awardee of this important contract that will bring new technology to Federal fleets by providing the new U.S. Government Fleet Services Card. This card will be accepted anywhere you find the Wright Express logo also pictured below. Today, close to 120,000 fueling locations accept the card – and more are being signed up every day.

Currently, thousands of invoices for millions of gallons of fuel are manually processed each month to run the Federal fleet. - EASY TO MONITOR PURCHASES Electronic point- ofsale processing enables the capture of detailed transaction data. You will know when full service and premium fuel purchases are made and when non-fuel purchases are

made. You will know the number of gallons pumped. You can eliminate unauthorized fuel purchases.

- **EASY TO PAY BILLS** Electronic point of sale transaction processing also allows for electronic payment reducing the flow of paper. Paper receipts will no longer be necessary, thereby reducing administrative costs.
- EASY TO BUDGET There are no monthly fees, no annual fees, no card ordering fees, and no hidden fees. There are absolutely no fees. The contractor will charge the fuel vendors not the card user a processing fee (this is standard in the credit card industry). # AN IMPORTANT NOTICE FOR OUR DEPARTMENT OF DEFENSE CUSTOMERS...

In a memorandum dated 5 April 1977, Subject: DoD Use of Recycled Content Copier Paper, the Deputy Secretary of Defense requests that DoD copier paper users comply with Executive Order 12973 ("Federal Acquisition, Recycled and Waste Prevention") and with the Resource Conservation and Recovery Act.

GSA recently reduced prices on recycled content paper-- NSNs 7530-01-335-2623 (8-1/2  $\times$  11) and 7530-01-334-7817 (8-1/2  $\times$  14) -- to levels below that of comparable virgin fiber paper.

The Deputy Secretary of Defense views the price reduction as a tremendous opportunity for DoD to meet its legal requirements and demonstrate environmental leadership by increasing its purchases of recycled content copier paper to 100 percent, while saving money at the same time.

The Deputy Secretary of Defense has requested that GSA substitute recycled content copier paper for all DoD orders, as long as the price of the recycled paper is equal to or less than comparable virgin fiber papers.

Consequently... effective May 7, GSA began automatic substitutions of MILSTRIP requisitions submitted for virgin fiber paper. If recycled content copier paper is out of stock, GSA will fill orders with copier paper produced from virgin fiber, thus eliminating concerns about timely delivery.

### MEMORANDUM FROM THE DEPUTY SECRETARY OF DEFENSE, DATED 5 APRIL 1997 SUBJECT: DoD Use of Recycled Content Copier Paper

Executive Order 12873, "Federal Acquisition Recycling, and Waste Prevention," and the Resource Conservation and Recovery Act (RCRA), establish a policy of reducing the use of all paper products and maximizing the acquisition and use of recycled content paper and paper products. The General Services Administration (GSA) recently reduced the price of recycled content copier paper (NSNs: 7530-01-335-2623 {8-1/2" x 11"} and 7530-01-334-7817 {8-1/2" x 14"}) below that of comparable copier paper produced from virgin fiber (attachment 1). This price reduction offers a tremendous opportunity for DoD to meet its legal requirements and demonstrate environmental leadership by increasing its purchases of recycled content copier paper to 100%, while simultaneously saving money.


To take advantage of this opportunity, we have requested that GSA substitute recleycled content copier paper: NSN's: 7530-01-335-2623 (8-1/2"x 11") and 7530-01-334-7817 (8-1/2" x 14") for all DoD orders for copier paper produced from virgin fiber NSN: 7530-00-181-7174 (8-1/2" x 11") and 7530-00-181-7175 (8-1/2" x 14") as long as the price of the recuycled content copier paper remains lower... We have made the request to GSA at this time for a number of reasons, including:

- -- Recycled content copier paper and copier paper produced from virgin fiber meet the same performance specification, supporting our acquisition reform initiative to use performance specifications
- -- Paper manufacturers have demonstrated that their new mills, specifically designed to handle recycled pulp and using state of the art technology, have significantly increased the quality of recycled content copier paper over the last decade
- -- Major copier manufacturers and computer printer manufacturers have demonstrated that recycled content copier paper works in their product as well as copier paper produced from virgin fiber
- -- Several other federal agencies, such as the Department of Energy, the Environmental Protection Agency, the National Aeronautics and Space Administration, GSA (for internal use), and the Executive Office of the President have instituted, or are about to institute, policies requiring the use of recycled content copier paper
- -- Eight state governments already have policies that require the use of recycled content copier paper
- -- The Government Printing Office has eighteen months of problem-free experience working with recycled content copier paper
- -- Increasing the demand for recycled paper should help stabilize the market for waste paper, thus increasing the price that installation recycling programs receive when selling their recovered paper

Existing DoD policy requires that we purchase designated products manufactured from recovered material unless one of three exemptions (price, performance, delivery) is applicable. The price of recycled content paper is currently lower, and our request makes provision for future price changes by permitting GSA to fill orders with whichever NSN a DoD activity orders when the price of recycled content copier paper exceeds that of copier paper produced from virgin fiber. In addition, our request permits GSA to substitute copier paper produced from virgin fiber if recycled content copier paper is out of stock, thus eliminating concerns about timely delivery. Finally, both recycled content copier paper and copier paper produced from virgin fiber meet the same performance specification.

This new policy regarding recycled content copier paper resembles similar DoD policies for other environmentally preferable products, such as our requirement for purchasing only computers that have the "Energy Star" seal, and our policy prohibiting the purchase of paints that contain lead. To insure a smooth and timely transition, I have requested that the Deputy Under Secretary of Defense for Environmental Security monitor DoD use of recycled content copier paper, and report on any performance problems encountered and on progress toward our goal of using recycled content copier paper 100% of the time. DoD support of quality products made with recycled materials will demonstrate our commitment to creating new markets for environmentally preferable products, and help achieve our environmental security goals.

### A REMINDER: IN EXPRESS SMALL PACKAGE DELIVERY SERVICE PROGRAM, AUTOMATIC MONEY-BACK GUARANTEE SUSPENDED FOR 60 DAYS

As a reminder, the suspension of the automatic money-back guarantee for late shipments on Federal Express invoices was effective on invoices dated February 25, 1997. The General Services Administration (GSA) granted approval for Federal Express (FedEx) to temporarily suspend, for 60 calendar days, the automatic adjustment on the invoice for credit for late deliveries of express small

package next day and second day shipments.

The suspension allowed FedEx the time to make computer changes to correct a system error that gave GSA contract users in some cases a credit for late delivery when the service commitment had been met.

Customers must call FedEx at 1-800-

463-3339 and request a credit for any late deliveries for shipments made during that period. The Automatic adjustment for service failures was reinstated on FedEx invoices for shipments on or after April 26, 1997.

#### **International Express Small Package Delivery Services**

GSA is once again partnering with the Department of Defense (DoD) to leverage the Federal Government's volume and service requirements to procure specific transportation delivery services. The Air Mobility Command (AMC) at Scott Air Force Base, Illinois will take the lead in procuring and managing the US Government contract for International Express Small Package Delivery Services.

The solicitation is intended to reflect the Government's requirements and customary commercial practice among potential bidders. # Re-Refined 15W40 Motor Oil in accordance with MIL. SPEC. MIL-L-2104 is now on contract

The Defense Supply Center, Richmond, has awarded a rerefined 15W40 oil contract to the Guard Corporation, of Kansas City, KS. This oil is procured in accordance with Military Specification MIL-L-2104, and contains a minimum 25% re-refined base stock. It meets the American Petroleum Institute (API) CD and CD-II performance levels and has been qualified by the Army's Mobility Technology Center-Belvoir, Fort Belvoir, VA. Re-refined Mil Spec 15W40 engine oil is available to all military and federal customers. Three NSNs may be ordered via MILSTRIP/FEDSTRIP as follows:

This oil is designed for use in all combat and tactical ground vehicles and equipment (both gasoline and diesel-powered) and includes performance requirements for power shift transmissions. This 15W40 re-refined oil may also be used in many hydraulic, power steering, power transmission, and gear box applications, as specified by the lube orders.

The 15W40 Mil Spec oil is on a Direct Vendor Delivery (DVD) contract, so the oil is fresh and shipped directly from the vendor's plant to your door within 30 days (for overseas customers, delivery may take slightly longer to reflect shipping times). And, for your convenience, there is no minimum order quantity for these DVD deliveries.

On October 20, 1993, President Clinton signed Executive Order 12873 on Federal Acquisition, Recycling and Waste Prevention. This Executive Order urges agencies to buy environmentally preferable products or products made with recovered materials. Re-refined oil is such a product. Upon signing this Executive Order, President Clinton stated: "Families, businesses, and communities all across

America know that recycling makes sense. It saves money and it protects the environment. It's time for the Government to set an example and provide real leadership that will help create jobs and protect the environment, encouraging new markets for recycled products and new technologies." According to the United States Environmental Protection Agency (EPA), Americans who change their own oil throw away 120 million gallons of recoverable motor oil by dumping it on the ground, by pouring it down storm drains, or by putting it in trash cans. Recycling this motor oil would save the United States 1.3 million barrels of oil per day.

Used engine oil contains contaminants which are picked up during use, as well as components of the additive package. The re-refining process, which consists of vacuum distillation and hydrofinishing, removes these contaminants and additives to produce a "new" base stock; thereby, allowing the oil to be reused.

According to The "Buy Recycled" Training Institute, every 10 days the equivalent to the EXXON Valdez spill occurs over the mainland of the US during routine oil changes. Re-refining creates the most responsible demand for used oil, while reducing irresponsible dumping.

Re-refined oil meets all of the warranty requirements for diesel equipment manufacturers. For a copy of the statements by Cummins, Detroit Diesel, and/or Caterpillar, call the number listed at the end of this article.

Buying re-refined oil and recycling used motor oil makes sense. It saves the environment, conserves our nation's resources, and supports legislation signed by the President.

Two electronic catalog tools are being distributed by DISC: FASTENER FIND and PLUMBER. These provide technical and management information on threaded fasteners (FSCs 5305 and 5306) and plumbing fixtures and accessories (FSC 4510).

#### The Technology:

These tools provide an efficient means of searching for and comparing items using pictures, descriptions, technical characteristics and CAGE codes. Items can be easily compared by their features and pictures.

Management Data (Price,
Acquisition Advice Code, etc.)

These catalogs are each based on a single CD-rom and run under a Windows graphical user interface. Any PC equipped with a CD-rom drive and running Windows 3.1, Windows 95 or Windows NT will be able to use the catalog.

Each tool has unique features. The PLUMBER Catalog contains a picture of each NSN in the stock class to ease comparisons of items and help assure that an item is right for an application. The FASTENER FIND Catalog contains over 400,000 NSNs and is specially indexed to allow the an NSN to be identified based on a simple description.

FASTENER FIND can locate an NSN in minutes based on a few simple technical characteristics. This allows NSNs for fasteners in systems without technical manuals or illustrated parts breakdowns to be found without costly telephone contacts or time-consuming research. Substitute parts and comparable items can also be found with relative ease.

The Vision of Electronic Catalogs:

The vision of DISC's Electronic Catalog Development Program is to be a means of supporting the DLA supplier-of-choice mission. These electronic catalogs have the same type of customer-oriented features that a commercial catalog has: descriptions, price and, most importantly, pictures of the items of interest. These electronic catalogs are central to DISC's goal of providing outstanding customer service. They provide a means of quickly linking customer needs and supply resources. The ultimate goal of these electronic catalog tools is to make DISC the most convenient way to procure an item.

Then the Concertainer Defense Wall is for you! The Concertainer Defense Wall is a rapidly built, solid-blast barrier wall made from heavy-duty wire mesh galvanized for corrosion protection. It is provided collapsed for ease of transport. The wall can easily be joined to create angles, extensions, walls, in fact almost anything the imagination can conjure up. The wall has no top or bottom. A standard wall has nine compartments—formed by panels joined together with spiral spring hinges, also in galvanized wire. The wire sides of each panel are lined with geo-membrane about 0.5 mm thick.

As you well know, there is a hard way and easy way to do anything. The HARD WAY: building a wall 3 foot by 3 foot by 30 foot would take ten people filling 1500 sand bags, for 7 hours. The EASY WAY: use two personnel using the Defense Wall and only take 20 minutes. Currently DSCC manages six different sizes of the wall in two colors (beige or green).



Schedule 26 I, "TIM", is a multiple vendor, user friendly Federal Supply Schedule offering the customer commercial products, competitive prices, convenience, and choice. The multiple vendor concept allows agencies to choose the tire which best meets their needs to safely, economically, and environmentally accomplish their mission. Tires offered under this Schedule have the seal of approval of the Department of Transportation (DOT).

Customers are reminded of the requirement to comply with Executive Order 12873 to purchase environmentally preferable products where practicable.

And now the easy part! Blanket Purchase Agreements (BPAs) placed under Schedule 26 I eliminate contracting and open market costs such as search for sources, the development of technical documents, issuing solicitations and evaluating bids/offers. Teaming Arrangements are permitted with Schedule 26 I contractors in accordance with Federal Acquisition Regulation (FAR) Part 9.6.

BPAs will further decrease costs, reduce paperwork and save time by eliminating the need for repetitive, individual purchases. The end result creates a purchasing mechanism for the Government that works better and costs less.

And don't forget your I.M.P.A.C. card. Several vendors on this Schedule accept the Governmentwide Purchase Card.

# More Choices Possible: What's *Your* Preference?

When our Customer Supply Center (CSC) ordertakers enter your order into our system, we occasionally find that we are out of stock in our normal shipping location for something you need. If that item is in stock at another location, your ordertaker will ask if you'd like to have it shipped seperately. If the entire system is out of stock, your ordertaker will offer to backorder the item, for shipment after stock is received.

For customers ordering by fax, it would be helpful to know what your preference is regarding referrals and backorders. A note on your fax order, like: "No backorders or referrals" or "OK to backorder or refer items" or "please call (name & telephone) if out of stock at the CSC" would help us serve you better.

We value your business, but want to be sure our referral and backorder options won't be a problem, particularly since shipments from alternate locations or at later dates may take a day or two longer to arrive than normal deliveries.

### Another Choice: Generic or Brand Name Items

Our Customer Supply Center (CSC) catalogs feature a number of "generic" NSNs, where suppliers and brands may change as new contracts are awarded, which means you might get a brand that's different from the picture in the catalog. Contracting for generic NSNs allows us to get good prices for items that satisfy a broad range of customers. However, more of our customers are letting us know that brand names are often meaningful in judging the value of the items they order.

We are currently working to expand our offerings of NSNs for specific brand-name products for situations when customers need to get exactly what they ordered. You can help us prioritize which brand name items we add to the system, by letting us know the items and brands most important to you. You can contact your local Customer Service Director, your local CSC, our National CSC telephone help line and National CSC EMail address.

### A NOTE TO OUR VALUED CUSTOMERS

When placing orders with our Multiple Award Schedule Vendors, especially when using the I.M.P.A.C. Card, customers are reminded to:

**Identify** yourself as a Federal Customer

**Ask** the Vendor for the Schedule contract number, and the contract price.

**Clearly identify** the order as an FSS contract sale, an order misclassified as open market could put you in violation of acquisition regulations

**Remember** the benefits to placing orders against the Schedule contract:

- -- Schedule contract buys comply with all applicable statutes and regulations
  - -- Prices have already been determined fair and reasonable
- -- Vendors can give additional discounts to an individual agency and are not required to pass it on to the entire Federal Government
  - -- Most prices are FOB destination, with freight included.

You get the added protection of ordering from a Government contract, rather than vendor dictated terms and conditions.

It is important to cite the contract number on all orders, but more so when there is no originating Purchase Order. A few vendors have expressed that when you call to make a credit card purchase, they are unclear as to your intention. They may treat you as a regular customer and price the item accordingly. There are many benefits in the GSA contracts that you are entitled to. You need to impress upon the contractor that you want all the benefits available under these contracts. Some vendors have been charging our customers freight when it's already included in the contract price. For large items, this can be a significant cost.

These issues have come to light as FSS has begun to do vendor visits to check compliance with the Schedule Contracts. In order to help us help you, we can verify the correct application of the schedule price list and contract terms when you have specifically notified the vendor that you are placing the order under the GSA Schedule Contract.

# First Aid Kits - A Necessity In Any Environment

Safety is often overlooked until it is too late. So, don't be caught without a first aid kit in the event of an emergency, whether it's in the office, in the field, on the road, or at the job site. GSA stocks 4 different first aid kits for all levels of need.

NSN 6545-00-656-1092 (\$8.75 each) is a one person kit in a small case suitable for putting in a pocket, desk drawer, glove box, belt pack, or backpack pocket. It contains dressing, bandages, bandage strips, iodine swabs, aspirin, acetaminophen, mouth-to-mouth barrier mask, gloves, towlettes, a biohazard bag, and instructions for use.

NSN 6545-00-656-1093 (\$61.45 each) is a 10 person kit for use in a vehicle or office, and comes in a hard case that can be hung on the wall. It contains everything that is in the one person kit plus many more types of bandages, a full antiseptic kit, an insect sting kit, a full body fluids barrier kit, and many other items, all in easy-to-grab unitized boxes.

NSN 6545-00-656-1094 (\$65.69 each) is a 25 person kit for use in a vehicle or office, and comes in a hard case that can be hung on a wall. It contains the same items as in the other kits, but in greater quantity or varieties, all still in unitized boxes.

NSN 6545-01-010-7754 (\$116.05 each) is a 25 person kit that is designed for the rugged use of a field work crew, and comes in a soft case with it's own belt. It contains the same components as the hard-cased 25 person kit, plus the additions of a mylar blanket and an 18" malleable splint.

These kits are specified by the USDA Forest Service for it's wild-land fire crews, so they meet the requirements for first aid kits in most workplaces. The kits are produced for GSA by people with disabilities through the Javits-Wagner-O'Day (JWOD) program. If you have any questions about these and their contents, or any other safety items, please
