Discussion Items

1. Voting on Architecture CRs

None this month. COACH Part 1 Version 4 and the associated CRs 5678 and 5692 will be voted on at the October CVISN ACCB meeting.

2. Volpe/CVISN: Report on new and open SAFER CRs and SAFER releases

Volpe presented a list of nine SAFER CRs. Some of them are old CRs that were approved but never implemented, and Volpe wants to know whether they are still relevant.

Regarding SCRs 18 and 173, states on the call thought that the information contained in the current T0032 is adequate. Neither MO nor WI was on the call to discuss. Note that these CRs and others on this list are also on the prioritization list for FY 2009.

Bill Goforth, Bill Guiffre, Chris Campbell, and Mark Bell will develop new CRs for escreening needs.

SAFER CR 2287 "Upgrade web service query from T0028v2 to T0028v3", which appears on the prioritization list, has been implemented and is now in beta testing, waiting for FL to develop the client.

SAFER CR 301 "LAST_UPDATE_DATE in T0031 does not reflect the correct date from MCMIS to SAFER transfer" will be closed, per discussion on the "Last Update Date" telecon held on 2008-09-17. A paper summarizing the applicability of dates is appended to these meeting minutes.

The SAFER release is still scheduled for 2008-09-30. SAFER CRs 1838 and 1854 will be included. SCR 89 will be late.

3. Prioritization of CRs

Volpe prepared a list of open SAFER CRs that is posted on the telecon workspace. Volpe will update this list for discussion at the October CVISN ACCB meeting. States will then vote on priorities for the FY 2009 SAFER Development Plan.

4. FMCSA Technical Support (Chris Flynn, Volpe FMCSA Technical Support Project Manager or designee)

Nebraska raised this issue:

Nebraska recently processed the T0026 baseline files we downloaded from SAFER, and my program received a data exception error when processing one of the files. After researching the cause of the problem, I discovered there was a record in one of the T0026 baseline files, where the IRP_CARRIER_ID_NUMBER contained the word "APPLIED", as opposed to a valid DOT Number or for that matter a 0. After reviewing the SAFER 8.1 Data Dictionary, I can see where the IRP_CARRIER_ID_NUMBER is described as an optional 12 character field. I don't have a problem with this field being optional, thus containing a 0 from time to time, but since it is a DOT Number field (as I understand it), shouldn't it at least be numeric? For the time being I can change my program to handle this situation, but since it is the first time I have seen this field contain something other than 0 or a DOT Number, I thought I would bring it to your attention. Maybe we need to open a CR to further discuss this situation?

This led to a discussion of whether a CR should be written to request that all data elements related to US DOT Number in the SAFER database schema be changed from "VARCHAR2" to "Numeric". This would be consistent with MCMIS. It was noted that this change would affect all the XML schema files. Also, it is perceived as being a problem that is caused by state systems, not by federal systems, and that the states should take responsibility for uploading valid data. It was also felt that the problem is not widespread.

5. Volpe/PRISM: Report on PRISM CRs relevant to CVISN stakeholders

The change to Query Central to display the IRP status field, requested by CVISN stakeholders at the 2007 CVISN Deployment Workshop, has been implemented and is

scheduled to be rolled out at the end of September 2008. The CVISN stakeholders noted that they use the IRP status field and they expect it to be exactly what the state supplies with registration data updates. If a vehicle is "active" many months after a registration expires, then that is a red flag for investigation. If a vehicle is taken out of service, then the status may be "inactive" prior to the expiration date. In most cases, the status should be "active" for any vehicle that is being inspected or screened. There is some concern by the PRISM program that it should not be displayed on Query Central because the data field is not well maintained by the states and is often incorrect and therefore confusing.

This issue is under review by FMCSA and will be reported at the next ACCB meeting.

Use of Update Dates in SAFER Transactions

The purpose of this paper is to clarify the meaning of various data elements related to information currency (i.e. date fields) that are used in SAFER transactions.

The following information, which is available in various sections of the Safety and Fitness Electronic Records (SAFER) Software Version 8.1 Interface Control Document, DRAFT Version 8.1, 2008, is summarized here:

For the T0028 vehicle data, LAST_UPDATE_DATE is the data element that should be used to check for the most recent data. This is the data element supplied by the states in the T0022 upload transactions and represents the date of change at the snapshot level, or for the transaction as a whole.

For the T0031 carrier data, FILE_CREATE_DATE is the data element that should be used to check for the most recent data. This is the data element supplied by MCMIS and represents the date when the file of changed carrier records is created by MCMIS and sent to SAFER. Volpe considers this to be a reliable field, consistently populated, and the recommended date source for checking data currency for the T0031.

Note that unlike in the T0028, LAST_UPDATE_DATE in the T0031 represents the last MCMIS Census data update. It does not represent the date for any other data element updates and it should not be used to check for most recent data at the snapshot level. Other data elements are available in the T0031 transaction to check dates for specific data items.
