UNANIMOUS CONSENT AGREEMENTS

S. CON. RES. 70

1.—Ordered, That when the Senate considers the conference report to accompany S. Con. Res. 70, an original concurrent resolution setting forth the congressional budget for the United States Government for fiscal year 2009 and including the appropriate budgetary levels for fiscal years 2008 and 2010 through 2013, all statutory time be yielded back except for 15 minutes to be equally divided and controlled between the Chairman and Ranking Member; provided, that upon the use or yielding back of that time, the vote on adoption of the conference report occur at a time to be determined by the Majority Leader following consultation with the Republican Leader. (May 22, 2008.)

S. 3036 (ORDER NO. 742)

2.—Ordered, That upon the conclusion of Morning Business on Monday, June 2, 2008, the Senate resume consideration of the motion to proceed to S. 3036, a bill to direct the Administrator of the Environmental Protection Agency to establish a program to decrease emissions of greenhouse gases, and for other purposes; provided, that the time from 4:30 p.m. to 5:30 p.m. be equally divided between the two Leaders or their designees; provided further, that the cloture vote on the motion to proceed occur at 5:30 p.m. on Monday, June 2, 2008.

Ordered further, That the mandatory quorum required under Rule XXII be waived. (May 22, 2008.)

S. 1974

3.—Ordered, That S. 1974, a bill to make technical corrections related to the Pension Protection Act of 2006, remain at the desk. (Mar. 31, 2008.)

VETO MESSAGE ON S. 5

4.—Ordered, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

Ordered further, That the message be held at the desk. (June 20, 2007.)

H.R. 3997

5.—Ordered, That if the Senate receives from the House a message on H.R. 3997, an act to amend the Internal Revenue Code of 1986 to provide earnings assistance and tax relief to members of the uniformed services, volunteer firefighters, and Peace Corps volunteers, and for other purposes, with an amendment that is not germane to the Senate amendment or the underlying bill, that the bill and its amendments be referred to the Committee on Finance.
