UNANIMOUS CONSENT AGREEMENTS

S. 2035 (ORDER NO. 434)

1.—*Ordered*, That at 10:00 a.m. on Wednesday, July 30, 2008, the Senate resume consideration of the motion to proceed to S. 2035, a bill to maintain the free flow of information to the public by providing conditions for the federally compelled disclosure of information by certain persons connected with the news media; provided, that the hour prior to the vote on the motion to invoke cloture on the motion to proceed be equally divided and controlled by the two Leaders or their designees with Senators permitted to speak for up to 10 minutes each, with the Senator from Vermont (Mr. Leahy) controlling 10 minutes of the Majority time, and with the final 20 minutes under the control of the two Leaders, with the Majority Leader controlling the final 10 minutes prior to the vote.

Ordered further, That with respect to the motion to invoke cloture on the motion to proceed to S. 2035, the mandatory quorum required under Rule XXII be waived. (*July 28, 29, 2008.*)

S. 3335 (ORDER NO. 898)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 3335, a bill to amend the Internal Revenue Code of 1986 to extend certain expiring provisions, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*July 28, 2008.*)

S. 1974

3.—*Ordered*, That S. 1974, a bill to make technical corrections related to the Pension Protection Act of 2006, remain at the desk. (*Mar. 31, 2008.*)

VETO MESSAGE ON S. 5

4.—*Ordered*, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

Ordered further, That the message be held at the desk. (*June 20, 2007.*)

H.R. 3997

5.—*Ordered*, That if the Senate receives from the House a message on H.R. 3997, an act to amend the Internal Revenue Code of 1986 to provide earnings assistance and tax relief to members of the uniformed services, volunteer firefighters, and Peace Corps volunteers, and for other purposes, with an amendment that is not germane to the Senate amendment or the underlying bill, that the bill and its amendments be referred to the Committee on Finance. (*Dec. 12, 19, 2007.*)
