UNANIMOUS CONSENT AGREEMENTS

S. 1082 (ORDER NO. 120)

1.—*Ordered*, That at on Tuesday, May 8, 2007, upon the conclusion of Morning Business, the Senate resume consideration of S. 1082, a bill to amend the Federal Food, Drug, and Cosmetic Act to reauthorize and amend the prescription drug user fee provisions, and for other purposes; provided that all time during any recess, adjournment, and period of Morning Business count against the bill post cloture; further, that any time used in Morning Business by any Senator be charged against his or her hour post cloture.

Ordered further, That second degree amendments be filed by 10:30 a.m. on Tuesday, May 8, 2007, notwithstanding Rule XXII.

Ordered further, That relative to the cloture motion filed on S. 1082, the mandatory quorum required under Rule XXII be waived. (*May 3, 7, 2007.*)

H.R. 1495 (ORDER NO. 128)

2.—*Ordered*, That with respect to the motion to proceed to H.R. 1495, an act to provide for the conservation and development of water and related resources, to authorize the Secretary of the Army to construct various projects for improvements to rivers and harbors of the United States, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*May 3, 2007.*)
