UNANIMOUS CONSENT AGREEMENT

S. 372 (ORDER NO. 20)

Ordered, That on Thursday, April 12, 2007, upon the conclusion of Morning Business, the Senate resume consideration of the motion to proceed to S. 372, a bill to authorize appropriations for fiscal year 2007 for the intelligence and intelligence-related activities of the United States Government, the Intelligence Community Management Account, and the Central Intelligence Agency Retirement and Disability System, and for other purposes, and proceed to a vote on the motion to invoke cloture on the motion to proceed.

Ordered further, That the mandatory quorum call under Rule XXII be waived. (*Apr. 10, 11, 2007.*)
