**UNANIMOUS CONSENT AGREEMENTS**

## S.J. Res. 9 (ORDER NO. 72)

1.—*Ordered*, That on Wednesday, March 14, 2007, following the time for the two Leaders, there be one hour of debate equally divided and controlled between the two Leaders or their designees prior to the motion to invoke cloture on the motion to proceed to S.J. Res. 9, to revise United States policy on Iraq, with the final 20 minutes prior to the vote controlled by the two Leaders and the Majority Leader controlling the final 10 minutes.

*Ordered further*, That with respect to the cloture motion filed on the motion to proceed to S.J. Res. 9, the mandatory quorum call under Rule XXII be waived. (*Mar. 12, 13, 2007.*)

## S. 214 (ORDER NO. 24)

2.—*Ordered*, That with respect to the cloture motion filed on the motion to proceed to S. 214, a bill to amend chapter 35 of title 28, United States Code, to preserve the independence of United States attorneys, the mandatory quorum call under Rule XXII be waived. (*Mar. 12, 2007.*)
