UNANIMOUS CONSENT AGREEMENTS

H.R. 1495 (ORDER NO. 128)

1.—*Ordered*, That at 3:00 p.m. on Monday, May 14, 2007, upon the conclusion of Morning Business, the Senate proceed to the consideration of H.R. 1495, an act to provide for the conservation and development of water and related resources, to authorize the Secretary of the Army to construct various projects for improvements to rivers and harbors of the United States, and for other purposes; provided that the Senator from California (Mrs. Boxer) then be recognized to offer an amendment.
