UNANIMOUS CONSENT AGREEMENT**H.R. 6 (ORDER NO. 9)**

Ordered, That on Tuesday, June 19, 2007, at the expiration of Morning Business, the Senate resume consideration of H.R. 6, an act to reduce our Nation's dependency on foreign oil by investing in clean, renewable, and alternative energy resources, promoting new emerging energy technologies, developing greater efficiency, and creating a Strategic Energy Efficiency and Renewables Reserve to invest in alternative energy, and for other purposes, there be 2½ hours of concurrent debate prior to a vote in relation to Amdt. No. 1628, offered by the Senator from Kentucky (Mr. Bunning) and Amdt. No. 1614, offered by the Senator from Montana (Mr. Tester); that the time be equally divided between Senators Bunning and Tester or their designees, and that upon the use or yielding back of time the Senate proceed to vote in relation to Amdt. No. 1628 followed by a vote in relation to Amdt. No. 1614; further, that there be 2 minutes for debate between the first and second votes and that no amendment be in order to either amendment prior to the vote.

Ordered further, That upon disposition of Amdt. No. 1614, the Senate debate consecutively the following amendments on which there shall be 30 minutes each with the time equally divided in the usual form and that the amendments be debated and voted on in the order listed at the conclusion of all debate time:

—Amdt. No. 1519, offered by the Senator from Wisconsin (Mr. Kohl),

—Amdt. No. 1609, offered by the Senator from South Dakota (Mr. Thune),

—Amdt. No. 1610, offered by the Senator from Maryland (Mr. Cardin);

further, that no amendments be in order to any of the above amendments prior to a vote in relation thereto and that there be 2 minutes for debate prior to each vote.

Ordered further, That each vote after the first vote in this sequence be 10 minutes in duration. (*June 18, 2007.*)
