**UNANIMOUS CONSENT AGREEMENT**

## S. 214 (ORDER NO. 24)

*Ordered*, That at 2 p.m. on Monday, March 19, 2007, the Senate proceed to the consideration of S. 214, a bill to preserve the independence of United States Attorneys.

*Ordered further*, That the bill be considered under the following limitations: That when the bill is reported, the committee amendment be agreed to and the motion to reconsider be considered as having been made and laid on the table and that the only other amendments in order to the measure be the following:

Kyl Amendment—Nomination and confirmation of U.S. Attorneys

Sessions Amendment—Appropriate qualifications for interim U.S. Attorneys

*Ordered further*, That the text of each of these amendments be printed in the Record once this consent is granted; that the amendments be offered and debated on Monday, March 19, 2007; and that debate time on each amendment be limited to 3 hours equally divided and controlled in the usual form.

*Ordered further*, That there be 6 hours general debate on the measure equally divided between and controlled by the Senator from Vermont (Mr. Leahy) and the Senator from Pennsylvania (Mr. Specter).

*Ordered further*, That on Tuesday, March 20, 2007, the Senate resume consideration of S. 214, and that there be 90 minutes of debate on the measure and the amendments to run concurrently with the time equally divided and controlled by the two Leaders or their designees; that upon the use or yielding back of time, but not later than 11:30 a.m., the Senate proceed to a vote on or in relation to the Kyl amendment to be followed by a vote on or in relation to the Sessions amendment.

*Ordered further*, That upon disposition of all amendments, the bill be read a third time, without further action or debate, the Senate proceed to vote on passage of the measure as amended.

*Ordered further*, That the motion to invoke cloture on S. 214 be withdrawn. (*Mar. 15, 2007.*)
