UNANIMOUS CONSENT AGREEMENT

CONFERENCE REPORT ON H.R. 1591

Ordered, That at 10:00 a.m. on Thursday, April 26, 2007, the Senate proceed to consideration of the conference report on H.R. 1591, an Act making emergency supplemental appropriations for the fiscal year ending September 30, 2007, and for other purposes, regardless of whether the Senate has received the papers from the House; provided that, the time immediately following the prayer and the pledge of allegiance until 12:45 p.m. be equally divided between the two Leaders or their designees; provided further, that at 12:45 p.m., the Senate vote, without any intervening action, on passage of the conference report, provided that the message has been received in the Senate. (*Apr. 25, 2007.*)
