**UNANIMOUS CONSENT AGREEMENT**

H.R. 1591 (ORDER NO. 84)

*Ordered*, That on Tuesday, March 27, 2007, upon the conclusion of Morning Business, the Senate resume consideration of H.R. 1591, an Act making emergency supplemental appropriations for the fiscal year ending September 30, 2007, and for other purposes.

*Ordered further*, That Amdt. No. 641 offered by the Senator from West Virginia is agreed to, and that the bill, as amended, is considered as original text for the purpose of further amendment with no points of order waived by virtue of this agreement; provided that Amdt. No. 643 offered by the Senator from Mississippi (Mr. Cochran) remain in order, notwithstanding this agreement.

*Ordered further*, That first degree amendments must be filed by 2:30 on Tuesday, March 27, 2007.

*Ordered further*, That with respect to the cloture motion filed on H.R. 1591, the mandatory quorum call under Rule XXII be waived. (*Mar. 26, 2007.*)
