THE URGENCY TO RESTORE CONSTITUTIONAL JUSTICE by  
DEFENDING AGAINST INVADING CORRUPTION

September 19, 1990

I. UNDER SACRED OATH TO DEFEND THE CONSTITUTION AGAINST ALL ENEMIES FOREIGN AND DOMESTIC, WILL THE NOMINEE, AS A JUSTICE ON THE U. S. SUPREME COURT, PROPOUND THE CONSTITUTIONAL FOUNDING PRINCIPLES FOR "REPRESENTATIVE GOVERNMENT, INDIVIDUAL RIGHTS, AND THE RULE OF LAW UNDER GOD," reasserted by President Reagan, July 4, 1982:

We are founded to legislate, propagate, and secure Christianity (western civilization), by the Christian common law; nothing be done to hurt Christianity. Bring infidels and savages unto human civility for a quiet and settled government, which cannot place Christianity in jeopardy, nor offend it. The morality of the nation is deeply engrafted upon Christianity. It is the duty of government to deter no-religion beliefs; secularism is unconstitutional, preferring those who disbelieve over those who do believe...The First Amendment was never intended to reduce Christianity to the levels of Judaism, Islamism, nor infidelity, (nor satanism, now propagated with public taxes). Holy Trinity Church, 1892; Engel, 1962; Abington, 1963; Jaffree, 1982, District Court; Lynch, 1984, Title 36, U. S. C. 172 - ONE NATION UNDER GOD; Public Law 97-280, 1982; Chicago Nativity Scene, 1987, dissenting opinion, Appeals Court.

II. Will the Nominee support C. J. Rehnquist loyalty against the Soviet Constitution, Art. 25 on "separation of church and state," and the deceptive judicial "three-prong test" - Lemon Test, imposed unconstitutionally by J. Brennan, usurping Constitutional moral order, and usurping Parental Sovereignty, Board of Education v Pico, 1982?

III. Will the Nominee by duty of the Oath, a religious commitment, DEFEND against anti-American internationalization imposed by the unconstitutional UNESCO Great Society Programs for the Soviet Constitution, "classless society, centralized education, socialization, 'legalized' militant labor union laws" which subvert the Constitution by centralized education and separation of church and state for international militant atheism -- destruction of western civilization, officially recognized in the Education Report to President Reagan, 1963, WE ARE A NATION AT RISK BY AN ACT OF UNDECLARED WAR?

IV. In Bondage to the U. S. Constitution, will the Nominee emphasize:

- 1) U. S. Christianity is the ONLY religion in the world which Constitutionally guarantees individualism for orderly citizens, Christian or non-Christian.
- 2) ONLY IN A CHRISTIAN NATION DO CHRISTIANS HAVE CIVIL RIGHTS. ONLY IN A CHRISTIAN NATION DO NON-CHRISTIANS, AWAY FROM THEIR LAND OF ORIGIN HAVE CIVIL RIGHTS, AND FAR MORE THAN AS A MAJORITY IN THEIR FATHERLAND. DEMY CHRISTIAN ETHICS, AND NONE SHALL KNOW FREEDOM.
- 3) God never endowed the anti-Godly with God-given, unalienable rights to molest and destroy Godly living - western civilization Christianity.
- 4) The Holy Scriptures forbid the subordination of the Supremacy of the New Testament, the basis for the U. S. Christian Constitution, SIGNED IN THE YEAR OF

OUR LORD, SUNDAYS EXEMPT FROM VETO DAYS.

5) The common culture is 96% Christian by founding purpose to secure Christianity by Euro-Christian concepts on color, race, religion, economy, education, economy -- the TOTAL CULTURE, for ONLY IN A CHRISTIAN NATION DO CHRISTIANS HAVE CIVIL RIGHTS, WILLING TO SHARE THOSE RIGHTS AND THEIR BLESSINGS OF FREEDOM WITH ALL ORDERLY CITIZENS.

To those demanding "You cannot put your religion on me," will the Nominee by Constitutional Divine Law guides in free government reassert, A CHRISTIAN NATION IS ENTITLED TO A CHRISTIAN ADMINISTRATION, with no considerations for the social convenience of abortions by deliberate murder of the unborn?

"OUR CONSTITUTION WAS MADE FOR RELIGIOUS PEOPLE. IT IS WHOLLY INADEQUATE FOR THE GOVERNMENT OF ANY OTHER." John Adams. # Christianity: Western Concepts for Law and Justice

The entire system of Christianity depends on Christ and His unchangeable doctrines. While differences may still exist among some who do not acknowledge unions of the Divine and human nature in any person, nonetheless, Christ is Second in the God-head of the Holy Trinity — the Father, the Son, and the Holy Spirit.

Scripturally, Christ serves as an intercessor between Christians and God, while Christians accept the fact that to stay or reconcile with God, Christians communicate with God through Christ! Naturally, how else can a Christian be a Christian, considering Christ from the God-head of the Holy Trinity?

A vital part of the Christian system is the essential Divine Guide for moral harmony — faith by acts of Obedient Obedience. These moral aspects of Christianity include love and belief in God; love and belief in Christ; and love of our neighbor as ourselves? By this Obedience, Christians obtain in western civilization upon the highest dignity, the inalienable, God-given rights for non-hostile citizens, whether ancestry or majority. Non-Christians, away from their land of origin, have no civil rights in any nation, but a Christian nation.

In fact, believing non-Christians are unconcerned about any "discomfort, diversified society, pluralistic society." They understand the common culture of 95 percent of Christians at the U.S. is the purpose of the founding of this nation, and the basis for the common law by concepts of western civilization, and that the religion provides more civil rights in a Christian nation than they ever had in their lands of origin.

It is the international militant atheism, disrespect of obligations the society by every citizen, who are intolerant of Christianity, by force, crime, and violence to deny Christian life, property, their children and liberty. Misrepresenting themselves as the one voice among their race, and misrepresenting laws and court decisions, buying politicians and laws, they attempt to infringe and control government to advance their money demands. With all their refutations, arguments, differences and rejections, they have yet to disprove history, that only upon divine law can liberty endure.

Christian Nations is entitled to a Christian Administration. At the time of the adoption of the

Constitution, and the [First] Amendment ... the present if not the universal sentiment in America was that Christianity ought to receive encouragement from the state so far as was not incompatible with the private rights of conscience and the freedom of religious worship. An attempt to level all religions and to make it a matter of state policy to hold all in utter inferiority would have created universal disapprobation, if not universal indignation.

"The real object of the Amendment [First Amendment — so established religion, state church] was not to countenance, much less to advocate, Mohammedanism or Judaism or Infidelity by protecting Christianity; but to exclude all rivalry among Christian sects, and to prevent any national ecclesiastical establishment which should give to a hierarchy the exclusive patronage of the national government." (Justice Story, U.S. Supreme Court).

"By establishment of religion is meant the setting up or recognition of a state church, or conferring upon one church of special favors and advantages which are denied others." (Justice Cooley, U.S. Supreme Court).

"We are founded to legislate, propagate, and secure Christianity; the common law ... Nothing he does to hurt Christianity ... Bring infidels and swarves into America ... Enter into confederations to maintain and preserve the liberty and purity of the Gospel of Lord Jesus ... Almighty God being the only God of Christians is the duty of every man to worship God, (un)confessed in religious liberty, unless he be in disturbance of moral order, peace, and safety of society. To scandalize these doctrines is extremely impious ... to revile with malicious and blasphemous contempt the religion professed by almost the whole community is an abuse of that right. We are a Christian Nation." (Holy Trinity Church v. United States, 1892, asserted into current cases).

Summary  
Christian law priority, Christian superiority, no established Christian church, favored by government favoring or disfavoring one Christian church over another

— this is the true meaning of the first amendment establishment, the discrimination of impostors and their separation of church and state, diversified society for militant atheism, Soviet Communism, 52, and Communist freedom, 22. 29. The Constitution is signed in the year of our Lord, Sunday except from who deny. Christianity is our common law, moral order, and guide in government. The Constitution is the Holy Scriptures forbid subordination of the supremacy of the New Testament! All free nations in western civilization are guided in government by Christian ethics, Divine Law for stability of justice, based on the common culture, common law.

This is the basis for God-given, inalienable, inalienable rights, against which the government cannot interfere, as long as actions are, like the nation, under God at all times!

Religion is not promoted by saying non-sectarian Christian school prayers, celebrating the legal-official holidays of Easter, Thanksgiving, Christmas with the Nativity and Christmas carols. No specific Christian church is favored or disfavored. Christian ethics belong in school curriculum and in government because we are endowed by our Creator. Those who advocate making prayers by discrimination and disorder are not entitled to such rights, for God never endowed any with hostility to his Divine Law. A Christian nation is entitled to a Christian administration. Being 95.5 percent Christian, 2 percent Jewish, 1 percent Islam. Here in the history of a diversified society? Only in a Christian nation do Christians have civil rights. Only in a Christian nation do non-Christians away from their land of origin have civil rights, and far more than as a majority in their fatherland. Only Christian ethics in government and none other freedom.

International Perspectives  
The above facts are the truth on what the First Amendment establishment clause means. But let us be in Christian nation, who respects, believe their manipulations and distortions applied for centuries around the world to "mobs and break civilizations," will work to destroy the USA. As long as Christians in Christian nations vigilantly, that will not happen, no matter how bitter the political battles

applied to control defenders. Indeed, non-Christians are not encouraged to others about the loss of liberties, for they fear repeat histories of Germany and Latin America where Jews fled with the tyranny of clergy and the bombings of churches.

"We will, like communist governments everywhere, the Socialists have launched assaults against ethnic and religious groups. The capital's only synagogues were desecrated and destroyed. In the Jewish community formed to flee Nazi Germany, Protestant Bible meetings have been broken up by mobs, by mob violence, by machine guns. The Catholic Church has been singled out — priests have been expelled from the country, Catholics beaten in the streets after midnight Mass.

The Catholic primates of Nicaragua, Cardinal Casco y Barro, has put the matter forthrightly. "We want to state clearly," he says, "that this government is totalitarian. We are dealing with an enemy of the Church." (State Department, Reagan, Policy 805, 1986).

Jews demand Christian law priority and Christian neutrality as a shelter for their religious, ethnic, cultural and economic security. They demand the acceptance of the anti-Christian, Rabbi Meier Kahane, The Jewish Press, 1989.

"America is not a melting pot, it is not a haven for the oppressed. Only the Christian Christians who, no matter how little they may practice at any given moment, are in the end, Christians who bitterly resent non-Christian bigotry and blasphemy and offend their faith. Any Jew of the law to do Christianize America will not only not succeed, but will so anger Christians as to bring about an explosion of terrible Jewish hatred. That is the effort of Jews to prevent official Christmas presentations or creches, Nativity, treat may win shortage victories — but at the expense of long-range disaster ...

The why when one reads that in England, Jews are infuriated by the fact that the Post Office has marked almost all letters with the words "Jesus is alive," one shudders. His head is in a dizzy. All the angry protests by British Jews are the post that England is a Christian country and if Christians in Israel would object to Jewish slogans and idolatry of the property, normal Jews would quite properly file no in indignation.

"If a Christian wishes to live in Israel,

he must accept that he is living in a Jewish country. The same holds true for the Jew if he willingly chooses to live in a Christian land, let him know it and not attempt to change it. On the one hand, he cannot. On the other, he will bring down on himself and his people tragedy."

Many Pro-American Jewish groups are speaking out, denouncing the anti-Christian onslaught of our Divine Law system of justice by concepts of western civilization, which is the prime target of such attacks.

# Anti-Christian Bias Criticized

The following speech was entered into the Congressional Record of May 24 by Rep. William Dannemeyer (R-Calif.)

Mr. DANNEMEYER. Mr. Speaker, Tustin is a moderately sized southern California city, a very small portion of the 29th Congressional District in which I have the pleasure to serve. The citizens of Tustin are your average hard-working, industrious Americans.

Like in other communities around the Nation, the Tustin City Council begins each meeting with an invocation, a prayer offered by a local clergyman or other local resident. It has always been the way—that is, until January 3 of this year.

It was on that date that Tustin mayor, Richard B. Edgar, wrote to the Rev. Don Wright and other area ministers that while the mayor was grateful for their service in providing invocation, no longer will they be able to invoke the name of Jesus Christ at the close of their prayers.

Upon the legal advice of Tustin city attorney, James G. Hauer, the mayor asked "that all speakers refrain from using language that might be construed as endorsing a particular religious belief." Counsel stated that, "It appears that most courts will tolerate religious invocations only if they fall short of endorsing a particular religious doctrine or belief." He also cites *Murray v. Chasobone* (483 U.S. 193 (1987)) as an example of the Supreme Court upholding legislative prayers "because the chaplain had removed all references to Christ."

Such an executive policy is clearly anti-religious, but it is most specifically anti-Christian. It is a legalistic ploy that the same U.S. Supreme Court which decided in 1962 to prohibit State prescriptions on the content of any prayer is the same court being cited by the mayor of Tustin, CA, to tell citizens just what they can and cannot say in prayer.

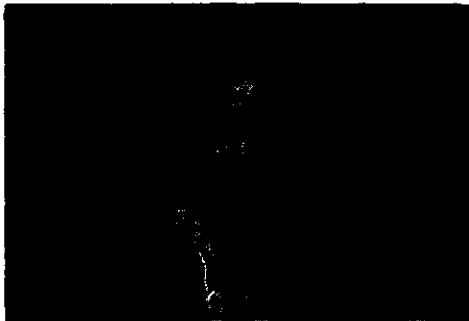
Mr. Speaker, our Judeo-Christian heritage is under attack in America. The attack is mostly subtle, a sprinkling of local complaints and subsequent court decisions which serve to slowly squeeze the religious life out of our national heritage. Sometimes the attack is brazenly offensive.

How often have we heard the plaintive cry of humanists that the Judeo-Christian ethic, and particularly Christianity itself, are responsible for the ills of America?

Humanists, they say, would be happy if only society would condone sex acts between men or two women, even though we be happy if only they could kill their own offspring without the burden of guilt; kids would be happy if only society would recognize the inhumanity of their parents' sexual relations, and Hollywood's elite would be happy if only society would properly care for its poor thereby relieving the guilt associated with million dollar incomes and 20,000 square foot homes occupied by the "hard work" of shedding one's sins on the big screen.

Christianity is the most oppressive external influence upon America, according to the new bigots. Hollywood, homosexuals, abortionists, family planners, the sexually promiscuous, self obsessed, selfish parents, and kids—all would be happy minus the Judeo-Christian ethic. Those Ten Commandments and that Sermon on the Mount can be so burdensome and restrictive. The best solution to relieve this burden is to get rid of it, or second best, put an amoral spin on it.

To pursue these solutions the new bigots have sought and nearly succeeded in taking control of our Government and our educational system. Control of the Government is necessary to oppress adults who believe in per-

sonal accountability, self-sufficiency, and religious freedom. While control of our educational system is necessary to oppress the children of these adults and offset familial influence.

Mr. Speaker, examples abound of how the secular lords of lunacy have used the Federal Government to oppress all who happen to disagree with their world view. However, the larger tragedy is what these new bigots have done to our kids by commandeering our educational system from the hands of parents and into the hands of unions, athletes, and lawyers.

Children who have managed to make it out of the womb are taught that killing children still in the womb is permissible in our society. Kids are taught that homosexual sodomy is normal behavior. Young girls are instructed by their adult supervisors that a line of virtue and subsequent conception is no more difficult of a problem than having an abortion. Oh, and next time there are always contraceptives available to prevent an unhappy reconnoissance of creation.

Our Constitution instructs kids that they have inalienable rights. But our Supreme Court, influenced by the demands of the new bigots, and set aside by our Constitution to interpret such issues, tells these kids that they cannot recognize their Creator in public school. Give such lessons to our children, are we surprised that kids manifest so many problems?

Mr. Speaker, permit me to take a moment to share with you an analysis of a gentleman named David Barton, many of Members know his work. All should. Mr. Barton fell inspired to correlate various social problems with the 1962 removal of voluntary prayer in public schools. Here is what he found:

The birth rate for unwed teenagers, per thousand, ages 15 to 19 went from 15 in 1962

to 26.5 by 1963. That's double the amount of legitimate births.

Pregnancies to unwed teenagers, per thousand, ages 15 to 19 increased fivefold from 100 in 1962 to 540 in 1963.

The same figure for girls under 15 years old quadrupled in this time period.

Scholastic Aptitude Tests have dropped 72 points from 1962 to 1968. And the drop was dramatic from 1962, not a gradual fall.

High school dropouts have increased tenfold from 1962.

Violent crimes per thousand have increased from 250 in 1962 to 1,237 in 1969.

Single parent households have doubled, while unwed couples have quadrupled since 1962.

Yes, the new bigots who pay multimillionaires to create any means to disprove quantitative studies in disagreement with the party line will say that any number of factors have contributed to these ills. But those who know the power of prayer, those who know the value of children recognizing their Creator, will know that Mr. Barton's analysis is accurate.

Mr. Speaker, we should begin to call it a specific epidemic. The successes of secular humanists, of the ACLU, of the People for the American Way, all the media such as "The Last Temptation of Christ" and the "Hamburger Tots," all the laws and court decisions which have kicked God out of our public schools, and all the venomous garbage of the left which seems to congeal it, but by no means limited to the Democratic Party are all examples of anti-Christian bigotry. They are not claims for justice or a defense of civil liberties. It is the vilification of the new bigots—and we should call it that from now on

## CURRENT COMMUNIST GOALS

1. U.S. acceptance of coexistence as the only alternative to nuclear war.
2. U.S. willingness to capitulate in preference to engaging in atomic war.
3. Develop the illusion that total disarmament by the United States would be a demonstration of moral strength.
4. Permit free trade between all nations regardless of Communist affiliation and regardless of whether or not items could be used for war.
5. Extension of long-term loans to Russia and Soviet satellites.
6. Provide American aid to all nations regardless of Communist domination.
7. Grant recognition of Red China. Admission of Red China to the U.N.
8. Set up East and West Germany as separate states in spite of Khrushchev's promise in 1955 to settle the German question by free elections under the supervision of the U.N.
9. Prolong the conferences to ban atomic tests because the United States has agreed to suspend tests as long as negotiations are in progress.
10. Allow all Soviet satellites individual representation in the U.N.
11. Promote the U.N. as the only hope for mankind. If its charter is rewritten, demand that it be set up as a one-world government with its own independent armed forces. (Some Communist leaders believe the world can be taken over as easily by the U.N. as by Moscow. Sometimes these two centers compete with each other as they are now doing in the Congo.)
12. Resist any attempt to outlaw the Communist Party.
13. Do away with all loyalty oaths.
14. Continue giving Russia access to the U.S. Patent Office.
15. Capture one or both of the political parties in the United States.
16. Use technical decisions of the courts to weaken basic American institutions by claiming their activities violate civil rights.
17. Get control of the schools. Use them as transmission belts for socialism and current Communist propaganda. Soften the curriculum. Get control of teacher's associations. Put the party line in textbooks.
18. Gain control of all student newspapers.
19. Use student riots to foment public protests against programs or organizations which are under Communist attack.
20. Infiltrate the press. Get control of book-review assignments, editorial writing, policy-making positions.
21. Gain control of key positions in radio, TV, and motion pictures.
22. Continue discrediting American culture by degrading all forms of artistic expression. An American Communist cell was told to "eliminate all good sculpture from parks and buildings, substitute shapeless, awkward and meaningless forms."
23. Control art critics and directors of art museums. "Our plan is to promote ugliness, repulsive, meaningless art."
24. Eliminate all laws governing obscenity by calling them "censorship" and a violation of free speech and free press.
25. Break down cultural standards of morality by promoting pornography and obscenity in books, magazines, motion pictures, radio and TV.
26. Present homosexuality, degeneracy and promiscuity as "normal, natural, healthy."
27. Infiltrate the churches and replace revealed religion with "social" religion. Discredit the Bible and emphasize the need for intellectual maturity which does not need a "religious crutch."
28. Eliminate prayer or any phase of religious expression in the schools on the ground that it violates the principle of "separation of church and state."
29. Discredit the American Constitution by calling it inadequate, old-fashioned, out-of-step with modern needs, a hindrance to cooperation between nations on a worldwide basis.
30. Discredit the American Founding Fathers. Present them as selfish aristocrats who had no concern for the "common man."
31. Belittle all forms of American culture and discourage the teaching of American history on the ground that it was only a minor part of the "big picture." Give more emphasis to Russian history since the Communists took over.
32. Support any socialist movement to give centralized control over any part of the culture, education, social agencies, welfare programs, mental health clinics, etc.
33. Eliminate all laws or procedures which interfere with the operation of the Communist apparatus.
34. Eliminate the House Committee on Un-American Activities.

35. Discredit and eventually dismantle the FBI.
36. Infiltrate and gain control of more unions.
37. Infiltrate and gain control of big business.
38. Transfer some of the powers of arrest from the police to social agencies. Treat all behavioral problems as psychiatric disorders which no one but psychiatrists can understand or treat.
39. Dominate the psychiatric profession and use mental health laws as a means of gaining coercive control over those who oppose Communist goals.
40. Discredit the family as an institution. Encourage promiscuity and easy divorce.

41. Emphasize the need to raise children away from the negative influence of parents. Attribute prejudices, mental blocks and retardation of children to suppressive influence of parents.

The NEA is an association of teachers whose salaries are paid by taxes levied on working Americans. Its leaders have declared that they intend to control the direction of education.
