- ☐ SIN 871-200 Energy Management Program Support Information on energy conservation, use of alternative energy sources, suggested upgrades of electrical and mechanical infrastructure, energy choice analysis, energy planning and strategies, and preparing agency statements of work.
- ☐ SIN 871-201 Energy Audit Services Information on energy conservation, planning and strategies, risk management, energy choice analysis, billing and management oversight, and preparing agency statements of work.
- ☐ SIN 871-203 Managing the Procurement and Use of Natural Gas Supplying natural gas and emergency power sources.
- ☐ SIN 871-204 Managing the Procurement and Use of Electricity Supplying electricity and emergency power sources.
- ☐ SIN 871-205 Managing the Procurement and Use of Electricity from Renewable Energy Sources Supplying electricity from renewable sources and for emergency power.


