### GSA/CENSUS JOINT VENTURE 2000

In a recent meeting with the U.S. Bureau of the Census, Support Services Branch Management Team, the GSA, Mid-Atlantic Region, Washington, DC, received accolades. The GSA, Mid-Atlantic Region, was commended for their continued outstanding support in the transportation of office furniture and equipment for all of the Local Census Offices (LCO) as required by the various locations and operations of those facilities.

We are now providing full transportation support of supplies needed by the 520 offices as Census moves into full operation of the 2000 Census. The Mid-Atlantic Region has established a transportation system of supply support covering CONUS, Alaska, US Possessions and Territories consisting of 50 Specialized Truckload (TL), Less-Than-Truckload (LTL) and Small Package Carriers with an overall reduction in transportation cost of 45%. This will be a 24- hours a day, 7-days a week operation covering the shipment of 700,000,000 pounds of supplies with allocated transportation funds of \$30,000,000.

The Mid-Atlantic Region is working closely with the Census to ensure any potential failure in transportation services resulting from any circumstance will be responded to immediately and remedied quickly including on-site visits to the Distribution Center at Jeffersonville, IN.
