## ERGONOMIC SOLUTIONS TO EMPLOYEES' HEALTH PROBLEMS

Many workplace injuries are caused by the performance of the same tasks repeatedly over a long period of time, causing strains on the musculoskeletal structure to the point of inflammation and possible permanent damage. When ergonomic principles are used in the design of desktop tools and accessories, etc., the causes for injury are eliminated — greatly reducing injuries, increasing worker's satisfaction, reducing absenteeism and increasing productivity.

It's just plain common sense. For example, wrist rests will not only support wrists but will maintain them in completely horizontal positions, preventing carpal tunnel syndrome and reducing pressure on the median nerve. Articulating, centrally-supported keyboard trays position keyboards at the proper low level for comfortable typing and leaving ample space for the knees.
