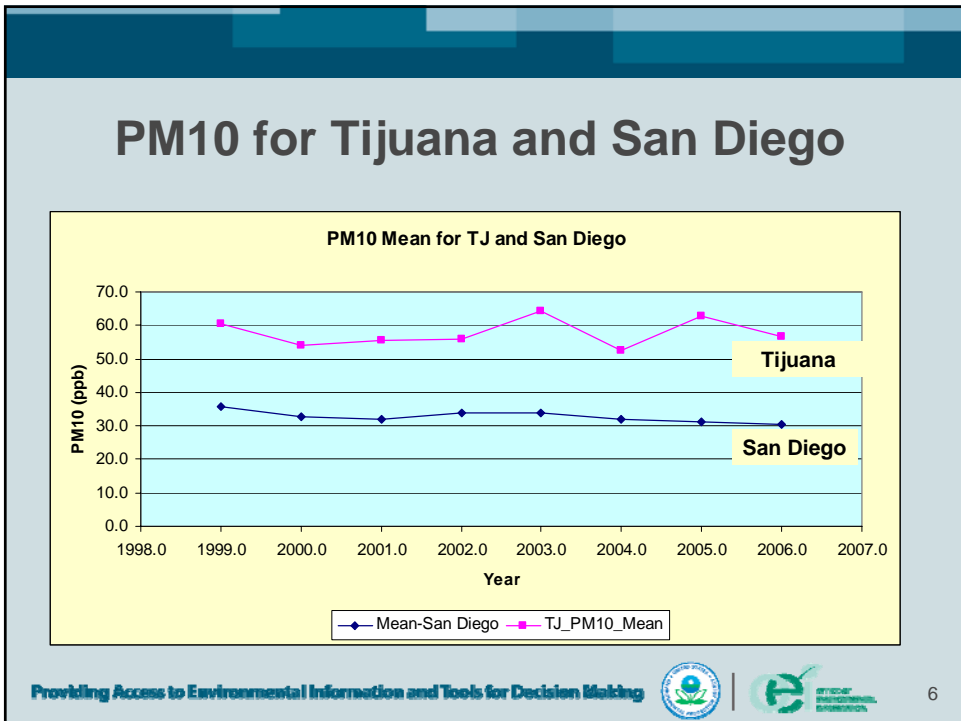

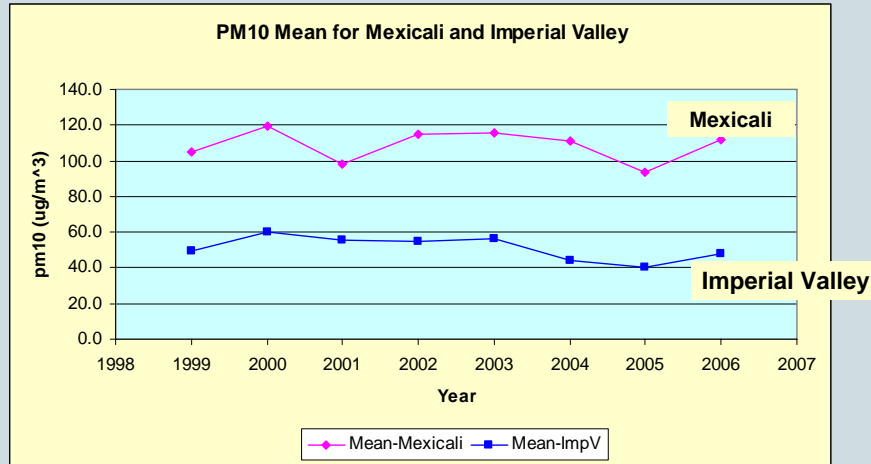

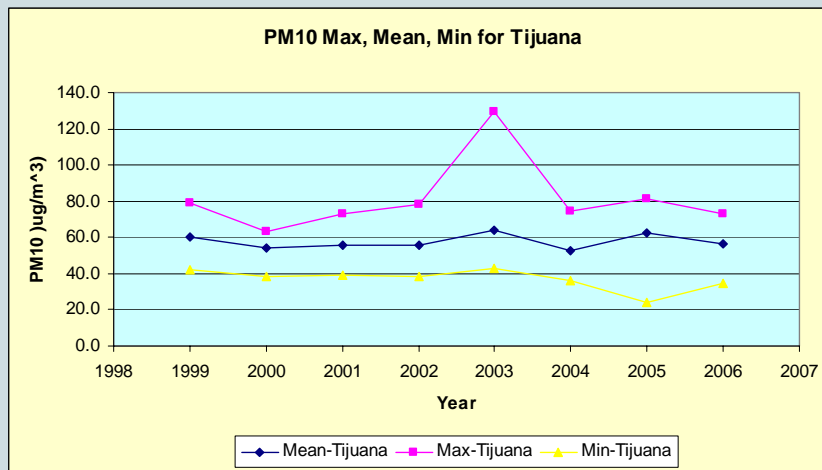
The Max. Mean and Min. of PM10 in Sub Regions

Max, Mean, and Min PM10 Values for Tijuana

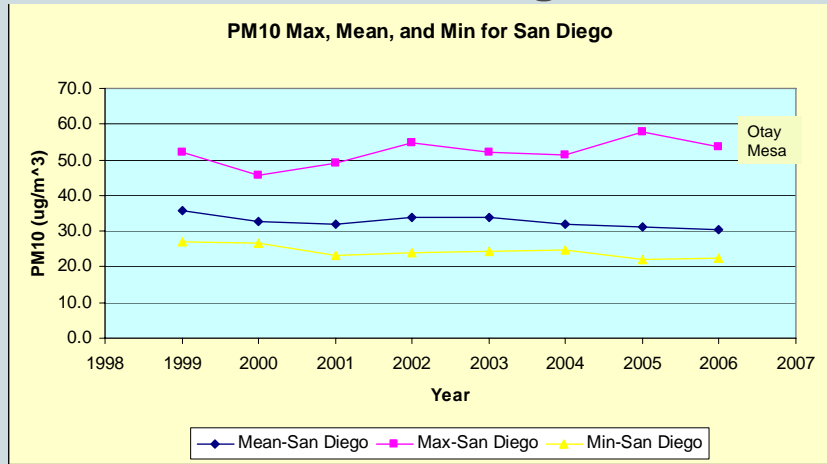

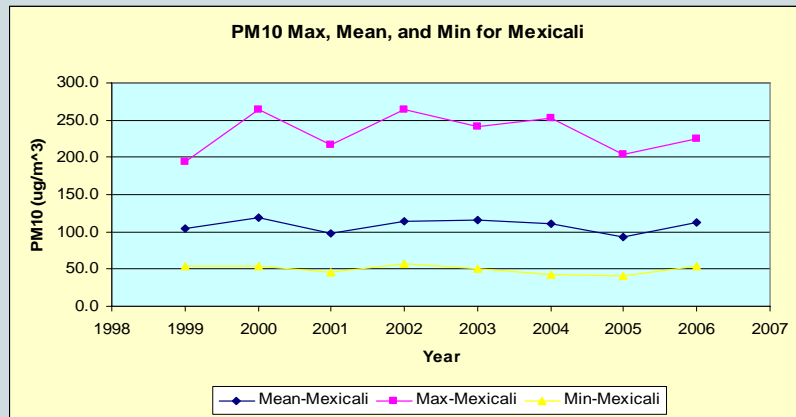

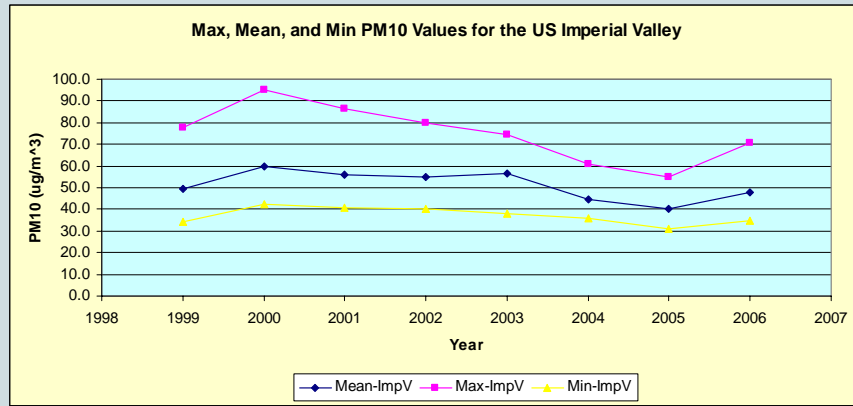

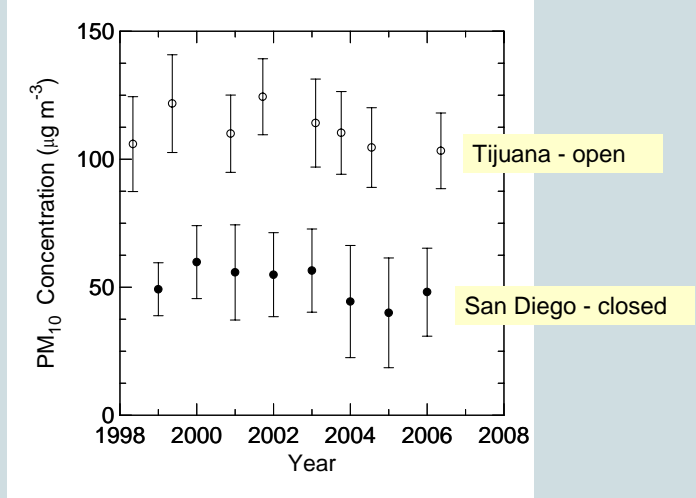

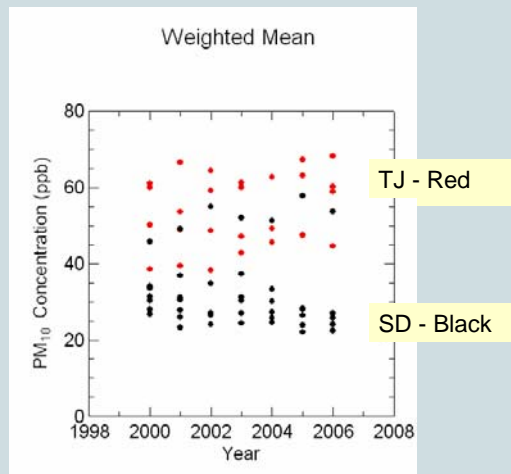

All the TJ/SD Data: TJ-Red, SD- Black

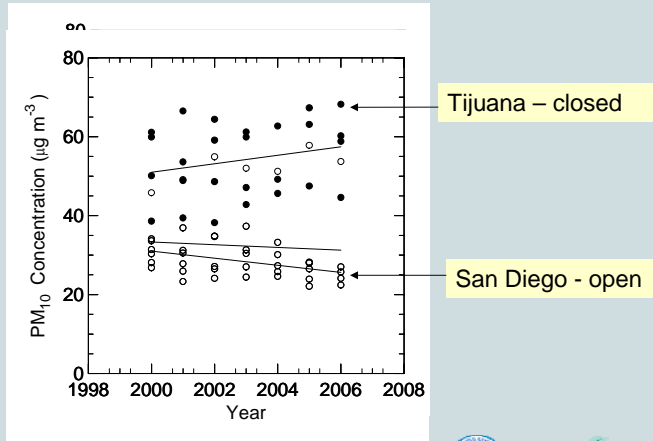

 Lower without Otay Mesa

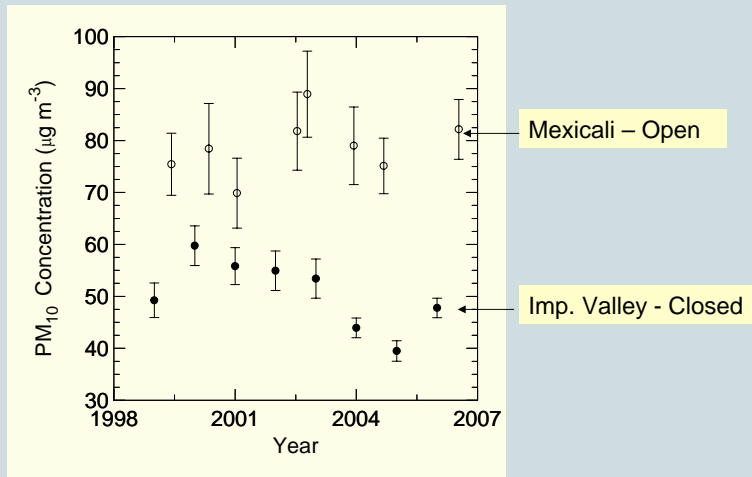

 90% Confidence Limits included

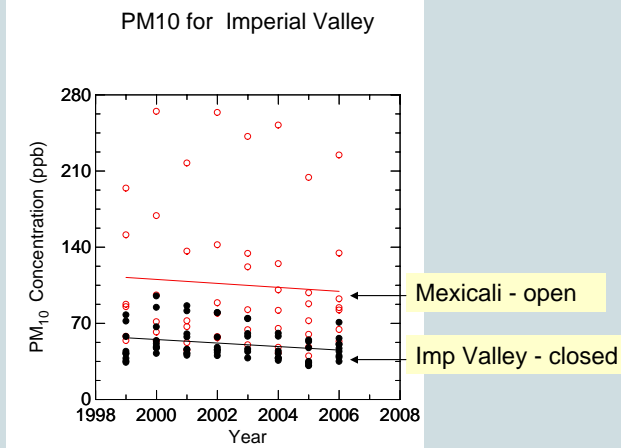

Points to Take Away

- Disaggregation and a little analysis allows focus on potential problem areas. For example you can see local trends or spot possible problem areas.
- This type of analysis may help target resource for both Mexico and the US
- This type of analysis may help tract environmental outcomes It allows you to better track environmental outcomes of proposals such as Dust Dampening Programs

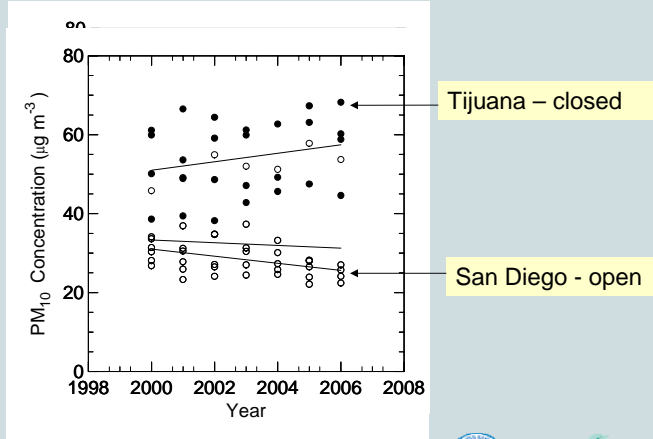
