Dear Mr. Patton:

The project to abandon CMS Trunkline Gas/Sea Robin 8" lateral, Line Segment No. 7731, was completed on February 12, 2001. This line segment consisted of approximately 9,852' of 8-5/8" X 0.438 and 0.500 WT pipe laying from Houston Exploration Company (HEC) East Cameron Block 185A platform location to the existing SSTI on the Sea Robin 30" mainline in East Cameron Block 197. The abandonment was carried out according to the procedures stated in the CMS Trunkline Gas letter of notification dated January 17, 2001 and the follow-up letter dated February 2, 2001. The line was filled with inhibited seawater and disconnected from the HEC platform, plugged and buried to a depth of 3' with sand/cement bags. At the SSTI the pipe was disconnected and an 8' segment was removed. The end of the 8" lateral was plugged covered with sand/cement bags and buried 4' below natural bottom. The Sea Robin SSTI was reburied with sand/cement bags and Submar mats to restore the required 3' minimum cover.

Included with this letter are copies of the original notifications to MMS dated January 12, 2001 and February 2, 2001.

Per my telephone conversation with Mr. Hennessey, please accept this letter as notification of completion of the Line Segment No. 7731 abandonment project and amend the MMS database to reflect the change in status of the pipeline segment.





CMS Trunkline Gas Company (TGC) has been notified by representatives of Houston Exploration Company (HEC) of HEC's plans to abandon and remove the HEC East Cameron Blk. 185A platform by March 1, 2001. TGC was asked to have all M&R equipment and all associated piping removed from the HEC facility prior to this date. TGC is in the process of arranging contractors at this time.

Prior to the March 1, 2001 date TGC will depressure and disconnect all associated piping. To accomplish this task TGC will abandon in place approximately 9852 of 8 5/8" X 0.438 and 0.500 WT pipe. The pipeline will be flushed with cleaning pigs and filled with inhibited seawater. The pipeline ends will be plugged and buried to a minimum 3' cover with sand/cement bags. The TGC SSTI location in East Cameron Blk. 197 will be buried to a minimum 3' cover with sand/cement bags and covered with Submar mats.

Upon completion of this abandonment project required reporting and revised asbuilts will be forwarded to your attention. A copy of the original construction asbuilts is attached for your information.





This letter of application revises the previous letter dated January 17, 2001.

CMS Trunkline Gas Company (TGC) has been notified by representatives of Houston Exploration Company (HEC) of HEC's plans to abandon and remove the HEC East Cameron Bik. 185A production platform by February 15, 2001. TGC was asked to have all M&R equipment and all associated piping removed from the HEC facility prior to this date. TGC has activated its contractor and is preparing to mobilize when weather permits.

Prior to the February 15, 2001 date TGC will depressure and disconnect all associated piping. To accomplish this task TGC will abandon in place TGC/Sea Robin Line No. 730, ROW No. OCS-G 8284/Segment No. 7731, consisting of approximately 9852' of 8 5/8" X 0.438 and 0.500 WT pipe. The pipeline will be flushed with cleaning pigs and filled with inhibited seawater. The pipeline ends will be plugged and buried to a minimum 3' cover with sand/cement bags. The TGC SSTI location in East Cameron Blk. 197 will be buried to a minimum 3' cover with sand/cement bags and covered with Submar mats.

Upon completion of this abandonment project required reporting and revised asbuilts will be forwarded to your attention. A copy of the original asbuilt construction drawings are attached to the previous letter, dated January 17, 2001, for your information.
