**DOT-E 6538  
(FIFTH REVISION)**

1. Pan Products, Inc., Macedonia, Ohio, is hereby granted an exemption from those provisions of this Department's Hazardous Materials Regulations specified in paragraph 5 below to offer packages prescribed herein of a certain flammable gas for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes use of a non-DOT Specification inside nonrefillable metal container, and provides no relief from any regulation other than as specifically stated. Each of the following is hereby granted the status of a party to this exemption:

Hanco International, Inc., North Miami Beach, FL - PTE-1  
Optimus, Inc., Bridgeport, CT - PTE-2  
Beltronic Marketing, Dorval, Quebec, Canada - PET-3  
Precise International, Suffern, N.Y. - PTE-4

2. BASIS. This exemption is based on Pan Products, Inc.'s application dated January 24 and June 7, 1984, submitted in accordance with 49 CFR 107.105 and 107.103 and the public proceeding thereon. The granting of party status is based on the following application submitted in accordance with 49 CFR 107.111, 107.105 and the public proceeding thereon:

Hanco International, Incorporated's application dated May 22, 1984  
Optimus, Incorporated's application dated June 15, 1984  
Beltronic Marketing's application dated June 22, 1984  
Precise International's application dated Sept. 11, 1984 and Feb. 6, 1985

3. HAZARDOUS MATERIALS (Descriptor and class). Butane, butane-propane mixture having vapor pressure at 130° F. below 105 psig, classed as flammable gas.

4. PROPER SHIPPING NAME (49 CFR 172.101). Butane or liquefied petroleum gas, as appropriate.

5. REGULATION AFFECTED. 49 CFR 173.304(d)(3)(ii), 178.33.

6. MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle and cargo vessel.

7. SAFETY CONTROL MEASURES. Packaging prescribed is a non-DOT specification inside metal container having a water capacity of 31.83 cubic inches or less, and meeting all requirements of Section 173.304(d)(3)(ii) and 178.33 except that:

- a. Inside diameter exceeds 3 inches but must not exceed 3.400 inches.
- b. The minimum wall thickness in all areas must be 0.010 inch, except in the area at the lower end of the three indentations in the sidewall at the top of the can. In this area the thickness must be at least 0.0079 inch.

- c. Maximum fill density must be as specified in 49 CFR 173.304(d).
- d. Pressure in the container must not exceed 35 psig at 70° F. and 100 psig at 130° F.
- e. Inside containers must not be marked "DOT 2P" but, instead, must be marked "DOT-E 6538."

8. SPECIAL PROVISIONS.

- a. Persons who receive packages covered by this exemption may reship them pursuant to the provisions of 49 CFR 173.22a.
- b. A copy of this exemption must be carried aboard each vessel used to transport packages covered by this exemption.
- c. Packages specified herein marked "DOT-E prior to the issuance of this exemption may be transported under the terms of this exemption.

9. REPORTING REQUIREMENTS. Any incident involving loss of contents of the package must be reported to the Office of Hazardous Materials Regulation as soon as practicable.

10. EXPIRATION DATE. June 30, 1986.
