The Office for Hurricane Katrina Oversight (OHKO), Office of Inspector General (OIG), Department of Homeland Security (DHS), has immediate job opportunities for individuals with several years of experience in criminal investigations and auditing work related to grants and contracts. These jobs include:

**AUDITOR, GS-511-9, 11, 12, or 13** (NOTE: Applicants must meet OPM Qualification Standards for the position. More information can be found on: [www.opm.gov/qualifications/SEC-IV/A/GS-PROF.HTM](http://www.opm.gov/qualifications/SEC-IV/A/GS-PROF.HTM))

**CRIMINAL INVESTIGATOR, GS-1811-9, 11, 12, or 13** (NOTE: The following requirements are mandatory for this position:

- The date immediately preceding an individual's 37th birthday is the maximum entry age for original appointment to a position within the OIG as a law enforcement officer.
- Selectee must satisfactorily complete the Basic Criminal Investigative training course at the Federal Law Enforcement Training Center in Glynco, Georgia, if an equivalent training course has not already been completed.
- Per the Lautenberg Amendment, any person who has been convicted of a misdemeanor crime of domestic violence cannot lawfully possess a firearm or ammunition [Title 18, U.S.C. Section 922(g)].
- Selectee may be entitled to Law Enforcement Availability Pay (LEAP) of 25% of base pay for availability to work substantial amounts of "unscheduled duty."
- Applicants must possess and maintain a valid state driver's license.

This office is responsible for the oversight of the management and expenditures of all contracts, grants and governmental operations related to Hurricane Katrina disaster relief efforts. As such, all positions allocated to this office will perform disaster related work in their area of expertise until the office has completed its mission, or is no longer needed. Annual Salaries will be commensurate with qualifications and experience, starting at \$37,390 plus appropriate Federal benefits. Positions will be located in Montgomery, AL, Baton Rouge, LA, Jackson, MS and Washington, DC.

## **REQUIREMENTS:**

- Applicant must be a U.S. Citizen.
- Background/Suitability Clearance for Public Trust position required and drug test.
- Candidates interested in Criminal Investigation work must be eligible to carry a firearm.
- Relocation expenses are not authorized.
- Travel will be required.
- Appointments will be made in the Excepted Service under the DAE or CORE hiring authorities from 6 months to 4 years for the applicable appointment type with an option to extend.
  - Annuity Offset waived for Federal retiree hired under DAE authority.
  - Appointments under DAE and CORE authorities do not convey civil service status.
