James T. "Skip" Duncan Gets SKILCRAFT "Advocate of the Year" Award From NIB

James T. "Skip" Duncan, Deputy Assistant Regional Administrator of GSA's Mid-Atlantic Region, was honored as the SKILCRAFT Advocate of the Year by National Industries for the Blind (NIB) for his outstanding dedication to and support of SKILCRAFT products made by people who are blind under the Javits-Wagner-O'Day (JWOD) program.

Duncan was recognized by NIB President Judith D. Moore at an awards ceremony in San Diego, CA, on May 19. (See photo at right.) In presenting the award, Moore praised Duncan's commitment to promoting the SKILCRAFT brand through his initiation of a product test market program at his Customer Supply Center in Franconia, VA. Under Duncan's direction, new SKILCRAFT products, including mouse pads, clam clips, rubberized pens, and mechanical pencils, were made available to Government customers for the first time.

As a further illustration of his commitment to the JWOD program, the customer service, order entry and invoicing



functions at Duncan's Franconia facility are performed by people who are blind employed by Virginia Industries for the Blind working under a service contract with GSA.

In presenting the award, Moore praised Duncan for his customer service operation, saying, "...it has demonstrated the capabilities of people who are blind and has bencome a model to pave the way for other, higher-level and computer-based jobs for blind people."



Update on World Wide (International) Express Small Package Delivery Service

GSA is once again partnershipping with the Department of Defense (DoD) to leverage the Federal Government's volume and service requirements to procure specific transportation delivery services. The Air Mobility Command (AMC) at Scott Air Force Base, Illinois, will take the lead in procuring and managing the US Government contract for World Wide (International) Express Small Package Delivery Service.

The solicitation is intended to reflect the Government's requirements and customary commercial practice among potential bidders. Representatives from GSA and the Departments of State and Justice have met on several occasions with AMC in an effort to merge the DoD and civilian agency requirements. The civilian agencies which have submitted service requirements to GSA can be assured that every effort is being made to include them in the procurement.

Draft copies of the Request for Proposal

(RFP) were available in April and May for review and comment by DoD customers, civilian agencies and organizations, and vendors. To view parts of the draft RFP, visit our website at **http:// www.fss.gsa.gov** and click on "Transportation Procurements." The final RFP is scheduled to be issued in the fall. AMC hopes to make award by the end of the year. DoD customers will be mandatory users of the contract. Civilian agencies may choose to sign up as a mandatory user before July 31, 1997.

Federal Government agencies and organizations that do no commit to be a mandatory user prior to July 31, 1997, may be precluded from participating in this contract. There is no cost to users of this contract (e.g., industrial funding fee). By signing up now, you are guaranteed the ability to take advantage of the special contract rates and services.

Wagoner, GSA, Assistant Regional Administrator (ARA) of the Federal Supply Service (FSS) in Atlanta, commissioned by Ms. Carole Dortch, Regional Administrator (RA), and supported by Mr. Jimmy Bridgeman, ARA, Public Buildings Service (PBS) and Ms. Janice Mendenhall, ARA, Federal Telecommunications Service (FTS). The Memorial was designed by Mrs. Pam Hale of GSA.





For The Best Value in the Sky... Use GSA's City Pair Program

This is the first of a three-part series of articles concerning the GSA's City Pair Program. This article addresses five of the most frequently asked questions.

Every year the GSA's Services Acquisition Center awards contracts for scheduled air passenger transportation services. The City Pair Program is the cornerstone of GSA's travel reinvention efforts and provides highly discounted airfare rates to over 6,000 airport combinations, (An example would be Los Angeles International to Washington Dulles International (LAX/IAD). Fast nonstop service for \$98.00.)

Frequently Asked Questions:

1. What are the advantages of the program?

- No advance purchases required;
- No minimum or maximum length of stay required;

- Fully refundable tickets and no charge for cancellations or changes;

- Seating not capacity controlled, (As long as there is a coach class seat on the plane, the traveler may purchase it);
- No blackout dates;
- Locked-in fares facilitate travel budgeting, and
- 62% average savings over regular walk-up fares.

2. Who can use it?

The City Pair Program is so attractive that usage is strictly limited. There are a few exceptions, but in general, only Federal or Military Employees on official travel, may use the program with an appropriate form of payment (Government Travel Charge Card or GTR).

3 Why can't contractors use it? It would save a lot of money! GSA recognizes that contractors often sit next to Federal Employees, work on the same projects as Federal Employees, and travel with Federal Employees. However, contractors are not Federal Employees. All of the major airlines (American, Continental, Delta, Northwest, TWA, United, and US Airways) have made it clear to GSA that because the contract rates are so low and the terms so favorable, the airlines would drop out of the City Pair Program rather than extend the contract rates to contractors. GSA has made the business decision not to jeopardize the program nor the 2.4 billion dollar savings it generates for taxpayers each year.

GSA cautions agencies that the purchase of contract fare tickets on behalf of cost reimbursable contractors is a misuse of the City Pair Program and could jeopardize its future success.

4. Do I have to use the Contract Carrier? Won't any airline do?

Federal and military travelers on official business are required to use the contract carrier unless a specific exception applies. This required use is the incentive necessary to obtain airline participation in the City Pair Program and allows the airlines the business volume necessary to offer discounted rates. Choosing not to use the contract carrier because of personal preference, frequent flyer clubs, etc., is a violation of the contract. The only exceptions to use of the contract carrier are:

1. No seats/flights available in time to accomplish the purpose of the travel. (For example, the contract flight is fully booked.)

2. A lower priced commercial fare is available. GSA advises traveler's to read the restrictions on such fares carefully. Often the non contract fares prohibit or charge for changes or cancellations, require advance purchases, Saturday stays, etc. If you can live with the terms of the fare, you can use it. (Most agencies find that non contract fares are not beneficial to their program because of all the restrictions that apply). If you see an attractive rate, check the contract carrier first, to see if they have a similar fare.

3. All of the flights are outside your core work hours and your agency has a written policy prohibiting travel outside core work hours. (This very seldom occurs.)

4. Cost-effective rail service is available and is consistent with mission requirements. Amtrak offers discount rates to Federal Travelers. GSA encourages use of Amtrak when appropriate.

5. Is there an Internet list of city pair carriers and fares?

City pair data is in beta-testing under GSA's web site. You will be able to find it soon under the travel section of GSA's home page at **www.gsa.gov**. While you're in GSA's web site, check out GSA *Advantage*!TM GSA's virtual shopping mall. From within *Advantage*!TM, click on the Services option to receive information on all the services GSA offers, including the airline City Pair Program.

Return Of The Mainframes

With the award of a Multiple Award Schedule contract to Amdahl in January 1997 and the expansion of ViON's contract to include Hitachi mainframe products in April 1997, the FSC 70, Part I, Section A, ADP Program now has mainframe products from the major plug-compatible mainframe manufacturers (IBM, Amdahl, and Hitachi on ViON's Schedule) on MAS contract. The anticipated market for these large scale computer "mainframe" systems is to become super servers to large networks of microcomputers.

ViON Corporation Marketing Manager Bobbi Terkowitz commented "ViON Corporation is very pleased that GSA now has mainframes from all three vendors on FSC Group 70. This will increase the competition in the high-end market, which will result in significant savings to users. Under the new regulations, the GSA schedule is a very competitive and timely acquisition vehicle, and the inclusion of all vendors' mainframes will greatly increase its value to Government customers. As mainframes take their place as enterprise servers in large networked environments, this ease of acquisition and ability to 'spot price' will be invaluable."

The 70IA Program was originally built around the mainframe computer but expanded to encompass a myriad of large-scale system products from Unix workstations to supercomputers. Over time the focus of the computer industry has shifted from mainframe computers first to minicomputers and then to microcomputers. Hardware sales for the 70IA Program shifted away from mainframe computers to servers and workstations manufactured by companies like Digital Equipment, Sun, Silicon Graphics, Hewlett Packard, and IBM and storage devices from companies like EMC. However, the return of the major mainframe manufacturers to 70IA provides the vehicle for expedited acquisition of large scale systems through competitive orders from the 70IA MAS contracts.

Under the new and improved ordering procedures, it is easier and more cost effective to place MAS orders. Expedited procedures for placing orders include the elimination of the requirement to publish a synopsis. In this competitive environment, field buying offices can now expect spot price reductions.

Effective October 1, 1997, the ADP Acquisition Center of the Federal Supply Service will merge the principal ADP/IT Schedules from 70IA, 70IB/C, 70ID, 70IE, 58VI and 58VII into a new consolidated one Multiple Award Schedule offering a complete array of ADP and Information Technology products and services. The name of the combined Schedule is the Federal Supply Service Information Technology (IT) Schedule.

After exploring various commercial and governmental alternatives, FISC has decided to partner with GSA to meet their customers' daily supply needs. As a result, on April 1, 1997, GSA Express at Uncle Sam's Club celebrated its official opening!

This partnership will provide an opportunity for FISC customers to explore the various worlds of GSA services and products via on-site customer service representatives, access to GSA Advantage!, GSA product displays, GSA catalogs and publications, direct telephone and ROCS computer access to the Franconia Distribution Center. Also present were representatives from the offices of Congressman Saxon and Congressman Smith as well as many customers who will be using the new facility. After the ribbon cutting everyone had the opportunity to tour the new facility and see first hand the large variety of products offered by GSA.
