NOTICE TO CSC CUSTOMERS

GSA is committed to continuous improvement in our supply programs. As part of that process, we are pleased to announce the simplification of our order tracking system. We are replacing our system of ticket numbers with a single order number to identify and track your order whether you call, fax or e-mail it to us.

What is changing?

Effective Monday, August 20, 2001, GSA's Customer Supply Center shifted to a single, 8-digit order number to identify each customer order. Customers are given this number during their phone conversation with the GSA call center, or see it on their confirmation of a fax order. The number also appears on the packing slip included in each shipment.

If there is any problem requiring a call to GSA's National Customer Service Center (1-800-488-3111), customers can use this number to help GSA staff identify the order in question.

How is that different?

Before August 20, GSA practice was to assign an 8-digit ticket number for every order, or partial order, shipped by a GSA warehouse. If a customer order was divided between two or more GSA facilities, a customer received two or more ticket numbers to use in tracking those orders and reconciling payments and credits.

What does this change mean for me?

In all aspects of our supply program, we aim to provide simple solutions. Using a single number to track each customer order should simplify record keeping for our customers and facilitate the identification and correction of any shipping errors. GSA staff handling customer calls, fax orders, shipping and customer service are committed to making this transition a smooth, productive one for our customers. “That may be easy for you”, comes the question. “What if I've never done a search on GSA Advantage? Where do I start?” Let's use LOGWORLD for an example. The quickest way to find a qualified logistician is to do a search on the word “LOGWORLD.” This search entry returns a sample of the companies that can provide logistics services under the Logistics Worldwide (LOGWORLD) Multiple Award Schedule.

By the way, did you know that you could customize your search results? You can sort by contractor or contract number and even determine how many results you see at one time. If the number of results overwhelms you, try doing a “Search Within Results”. This feature helps you drill down to the information you really need!

At this point, you should have a list of customized search results. Do you see a couple of companies that you'd like to learn more about? All you need do is click on the hyperlinked company name and a vast amount of contractor specific information will be right at your fingertips. Wait times vary according to what the contractor has posted on the website. Typical information at your fingertips includes:

- Contractor Number
- Contact Information
- Labor Category Descriptions
- Capabilities
- Awarded Special Item Numbers
- Socio-economic status
- And more!

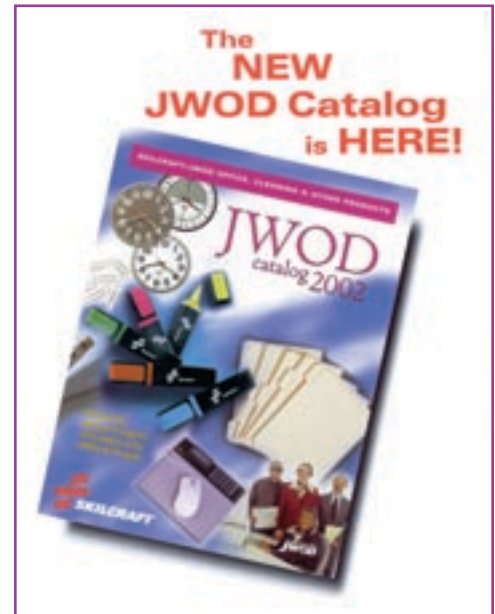
