Second, its exceptional portability permits quick installation and allows workers to move the length of the barrier as the work proceeds up the runway, which reduces the number of work order changes necessary in the project. Third, the bright orange and white Multi-Barrier AR-1 gives high visibility delineation for pilots.

The AR-1 unit provides better visibility to pilots and less maintenance problems. The unique shape deflects the jet blast and is low enough not to interfere with air traffic. The resiliently plastic barrier will prevent damage to aircraft and equipment. In addition, many airport authorities are now replacing concrete barriers on their airfields with plastic, water ballast barriers as the plastic units will not break apart like concrete barriers. Once the smooth surface finish of the concrete has been violated, loose aggregate can be sucked into jet engine intakes. Plastic barriers are also excellent for fueling station safety and security, as plastic will not spark when struck by a metal object.

According to the Federal Aviation Administration (FAA), poor runway markings are a significant cause of ground accidents. Poor marking of construction zones, freight ramp areas, and other hazards primarily caused a significant number of ground accidents involving aircraft. One pilot suggested the following, "surely there is some sort of marking which can be added to close hazardous taxiways."

The hole is then filled with concrete mix, thus securing the staples and the fire ring in place. The log grate eliminates the need for filler materials such as gravel, thus allowing ease of tipping for cleaning and drainage during rainy periods.


