The 1122 Program

The National Defense Authorization Act (Section 1122) dated November 10, 1993, established the authority for state and local governments to purchase law enforcement equipment through Federal procurement channels, provided the equipment is used in the performance of counter-drug activities.

The Automotive Division is able to assist you with your vehicular needs to accomplish your mission of counter-drug activity. We can provide you with a wide selection of compact, midsize and fullsize sedans, as well as a variety of 4x2 and 4x4 pick-up trucks, and vans. The selection includes a wide variety of makes and models from Ford Motor Company, General Motors Corporation and DaimlerChrysler Corporation. With the expansion of the program, you may now purchase under Federal Supply Schedule 25 I A, Vehicular Equipment and Accessories and Schedule 42 IV, Fire Fighting and Waste Disposal Vehicles (Limited to Command Centers Only).

It is emphasized that State and Local Governments may place orders solely for vehicles to be used in their counter-drug missions.

NEED STORAGE SPACE?

Well, now you can have storage shelves. Federal Supply Schedule 25 III C, Vehicular and Automotive Parts Steel Storage Shelves, allows you to have that extra space to store your automotive parts.

Special Item Number (SIN) 325-101, Storage Shelves For Automotive Parts are free standing racks for such uses as storing exhaust systems, glass, cable, bulk and other large vehicular and automotive parts. SIN 325-102, Multiple Use Storage Shelves are flow rack steel storage shelves and/or free standing racks for smaller items like nuts and bolts. SIN 325-104 allows for New Technologies. Shelving is available in various heights and dimensions and is designed for use with recommended load ratings. Some are even adjustable.

The contract period runs through November 30, 2002, with one 5 year option.

Delays on Delivery under STAN for Vehicles with Automatic Transmissions

Since early 1998, the medium and heavy truck business has been booming with almost unheard of sales volumes from all of the major manufacturers. This sales boom has, unfortunately, caused a shortage of automatic transmissions. There is only one manufacturer, Allison Transmission, who produces an automatic transmission for medium and heavy vehicles.

Due to the incredible demand industry-wide for new medium and heavy trucks, this shortage of automatic transmissions has resulted in significant delays in delivery on medium and heavy trucks under the STAN Program. While GSA's Automotive Division will continue to strive to fulfill your requirements, this shortage is affecting the entire industry and expedited or even 'normal' delivery is sometimes not possible.

We are now experiencing significant delays where, at best, delivery will be 180 days after receipt of order (ARO) and may extend up to 300 days ARO.

GSA is able to provide timely delivery with manual transmissions. If a manual transmission cannot meet your needs, we ask that you be aware of the extreme delays – and plan accordingly.

We do not anticipate relief of this shortage during the coming year and thank you for your understanding and patience.
