# Re: Mid Term Review of Joint Project Agreement (JPA) between United States Department of Commerce (DoC) and ICANN

The Pacific Islands Telecommunications Association (PITA) is a non-profit organisation formed to represent the interests of small island nations in the Pacific Region in the field of telecommunications and ICT. Full members are from 22 economies from the Pacific, which includes, Telcos, ISPs, Regulators and ccTLD registries.

Thank you for the opportunity to provide comments on the continued transition of the technical coordination and management of the Internet's domain name and addressing system.

We have the view that Internet governance should never be **controlled** by any one government, organisation or individual as this is a global resource for everyone.

For the issues from the Pacific Islands region, the technical coordination and management of domain name and addressing system, we appreciate and value the role of ICANN, which is the organisation tasked to **coordinate** the domain name and addressing system on behalf of and participation of all stakeholders.

In this submission, PITA does not propose to individually address each of the ten areas set out in the Request for Comment, but do however note ICANN is meeting its responsibilities under the JPA. PITA, therefore support the continuity of ICANN as having the processes to identify, and resources to undertake, what needs to be done, in that course, PITA has established an MoU with ICANN to support the common goal of enhancing coordination and management in the Pacific region
