






How SART Got Its Start



Why SART Works

- Common mission for animal emergencies
- Proven method (ICS)
- Private entity (501C3) with public partnership



• Team Approach

What the Partners Offer

- <u>Public Entities</u>: Consistency, legal authority, and statewide presence.
- <u>Private Organizations</u>: Zeal, abilities, rapid deployment, solutions and availability of funds & funding mechanisms.
- <u>Animal Industries</u>: Need, experience, mandate to be responsible & fund.

Incorporation

- Incorporation involves becoming a private, non-profit organization
- 501(c) 3 tax-exempt status
- Needs bylaws and board of directors
- Allows for fundraising and memorandum of understanding with other entities
- Allows the purchase insurance

Building Trust & Credibility

- Code of Conduct
- Volunteers and organizations must be activated, and similarly can be deactivated by the Incident Commander



Strengths of Code of Conduct

- Volunteers and participants represent the entire SART organization
- Protects the integrity of SART and of those who respond to disasters on SART's behalf
- Each SART participant must agree to read, sign and abide by this code

Building a Team of Responders

Veterinary experience is NOT necessary to be a valued responder.



Building a Team of Responders

Disaster response requires volunteers with a wide range of skills and experience.



Building a Team of Responders

In addition to providing emergency animal care, we need responders to:

- Perform office functions (filing, in/out
- Answer phones
- Manage supplies
 and equipment



Building a Team of Responders We also need responders who have access to:

- Four wheel drive vehicles
- Cranes & Bobcats
- Chainsaws
- Other heavy equipment
