Owner: NCDENR (North Carolina Department of Environment and Natural Resources), Division of Water Quality.

#### **GROUND-WATER RECORDS**

WELL CHARACTERISTICS.--Drilled observation well, depth 23 ft, diameter 4 in., cased to 8 ft, screened interval from 8 ft to 23 ft, sand filter packed from 6 ft to 23 ft.

DATUM.--Land-surface datum is 830 ft above North American Vertical Datum of 1988. Measuring point: top of PVC casing, 2.48 ft above land-surface datum, May 12, 2006, to present.

PERIOD OF RECORD.--May 2006 to current year.

GAGE.--Measured periodically with electric tape (by USGS and NCDENR, Division of Water Quality).

REMARKS.--Well is part of Piedmont/Mountains groundwater project.


