

# TELECOMMUNICATIONS LOCAL SERVICES CONTRACT FOR LOUISIANA

The Greater Southwest Region awarded this Local Services Acquisition (LSA) contract to BellSouth. This is an Indefinite Delivery, Indefinite Quantity (IDIQ) telecommunications local services contract for areas within the State of Louisiana. The LSA has a base period of two years with three one-year options. This contract offers a wide range of voice and digital local services. These offerings include both circuit switched and dedicated transmission services, extending from a single analog line to Primary Rate Interface (PRI) services, to point-to-point data connectivity, to DSL. For analog "Centrex-type" service, this BellSouth award will provide federal agencies an average 45 percent cost savings over tariff rates.
