Be the first to attend the AES Compliance Seminar in Seattle since the release of the New Foreign Trade Regulations (FTR). The Customshouse Brokers and International Freight Forwarders of Washington State (CBIFFAWS) is sponsoring an Automated Export System (AES) Compliance Seminar and Workshop in the Puget Sound area on December 11 & 12, 2008.
