Item 1. COMPRO Database (part of Trade Policy Information System [TPIS]). The COMPRO database provides for on-line data retrieval of timely and consistent trade data. COMPRO is widely used in the U.S. government trade community. Trade Development, International Economic Policy, and other Federal government trade community organizations and agencies use COMPRO to access trade data and trade policy information. COMPRO contains U.S. import data in net quantity, value, transportation, commodity, country of origin, and rate provision. COMPRO contains U.S. Exports of merchandise in quantity, value, commodity and country of destination. COMPRO also contains UN trade data and IMF World Bank statistics on finance and debt. Sources include the Bureau of Census, the International Monetary Fund and the World Bank. Also the United Nations is a source for UN import/export trade data. The system was established in 1982.

- a. Electronic Data: PERMANENT. Transfer COMPRO records to the National Archives.
- b. Documentation: PERMANENT. Transfer documentation with the COMPRO records.
