

14. Description of Amendment/Modification (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The Purpose of this Modification is to incorporate a revised Performance Work Statement (PWS), dated September 20, 2007 (see Attached). The document replaces Attachment I of the contract. The specific changes are as follows:

1. In addition to minor wording changes, substitutes language in the PWS, replacing the type of credit card system used from "MasterCard" to "Visa".

There is no additional cost to the government associated with this modification, and the total dollar value of the contract remains unchanged.
