Year-End Summary

Fiscal Year 2007 officially ended with IT Schedule 70 federal sales at \$16.31 billion which was \$41 million less than last years federal totals. Cooperative Purchasing exceeded last years sales by reaching \$323 million. Corporate Schedule sales were \$286 million, slightly lower than the \$297.42 million that it was last year.

Due to decreasing agency IT budgets, new sales competition from government wide acquisition contracts and other multiple award contracts scales were down from last year amount of \$17.2 billion to a total of \$16.96 for the FY 2007. GSA also faced a reorganization in which GSA has made great strides. With that being said IT schedules, continues to be a popular contracting vehicle accounting for 26% of the Federal IT market share.

State and Local governments continue to expand their use of the IT Schedule 70 Cooperative Purchasing Program. In FY'2006 sales totals were \$240 Million. In FY'2007 sales increased by 34.5% (\$80 Million in sales) for a year end total of \$323 Million for the Cooperative Purchasing Program. GSA Schedules 70 facilitated the new Software Managed and Acquired on the Right Terms (SmartBUY) Program this year. SmartBUY is a Federal government-wide enterprise software licensing initiative conducted by GSA in coordination with The Office of Management & Budget. This initiative allows the federal government to leverage its software package buying power to achieve maximum cost savings across DOD and civilian government agencies.

State & Local governments will find SmartBUY a cost effective procurement as they are able to collectively consolidate software purchases for greater volume-based savings. Currently there are eleven SmartBuy agreements available for Data-at-Rest (DAR) encryption product procurements.

Several positive notes this year:

- 1.GSA received unqualified "clean" opinion on FY 2007 Financial Statement
- 2.Ranked as one of the top 10 places to work
- 3.Completed transition to the Federal Acquisition Service in May

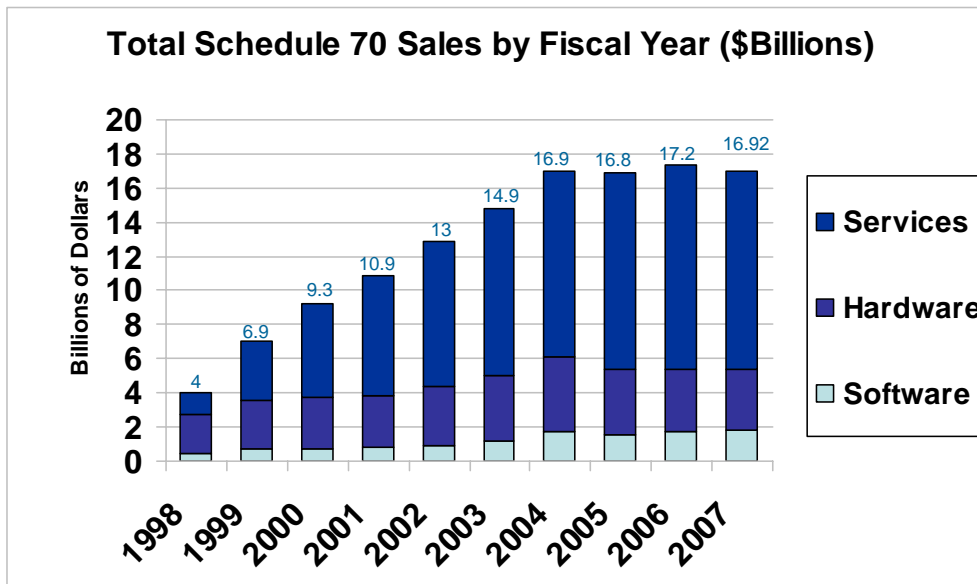

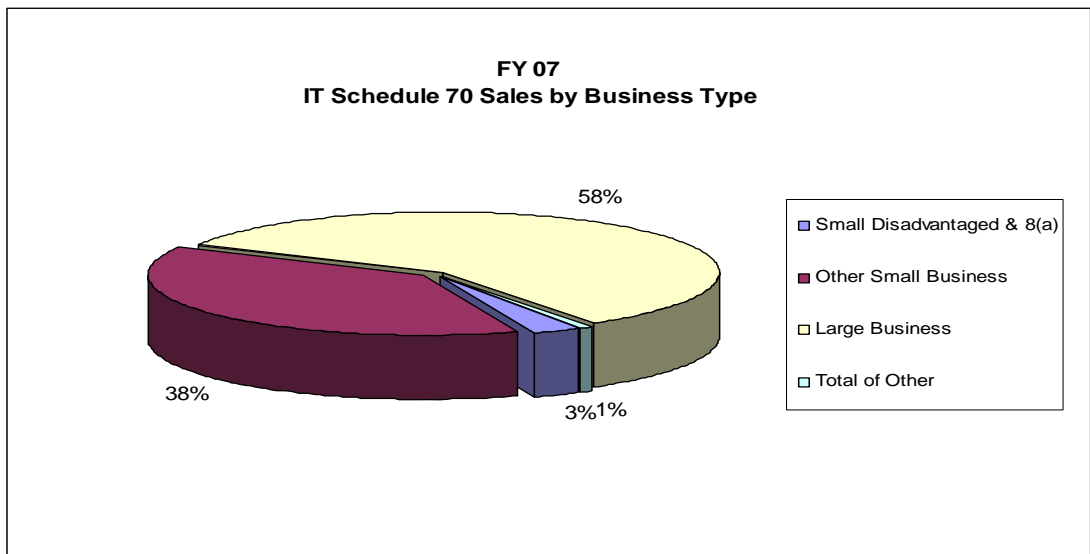

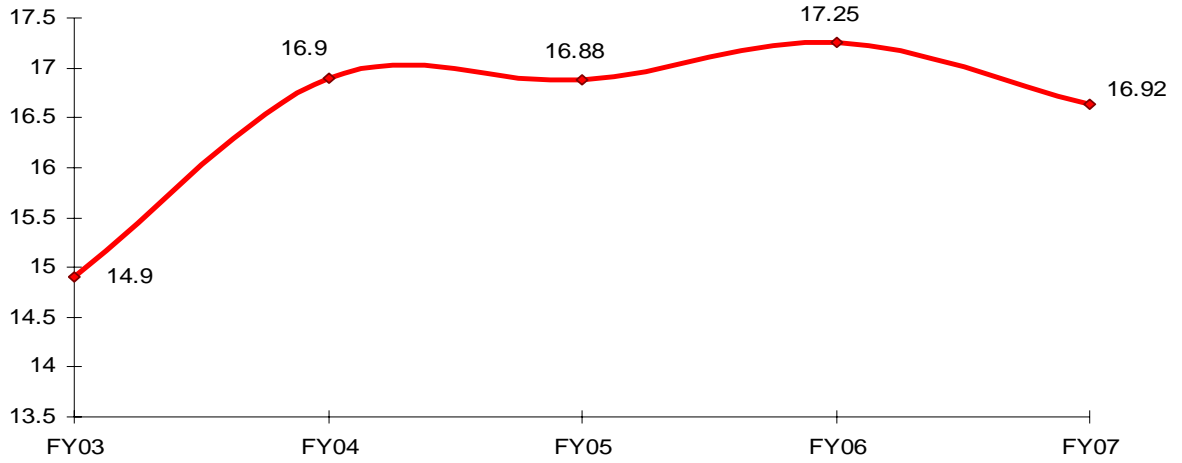

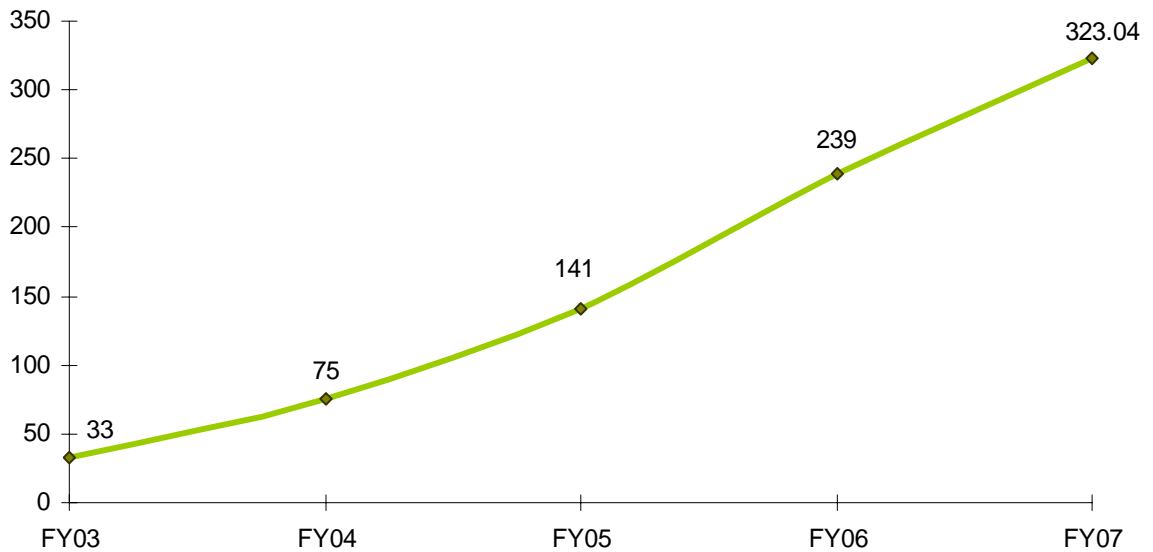
Total Schedule 70 Sales

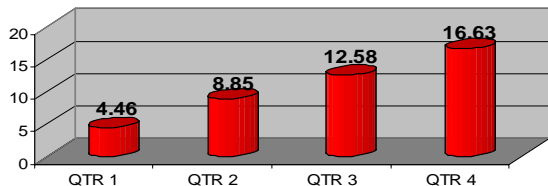

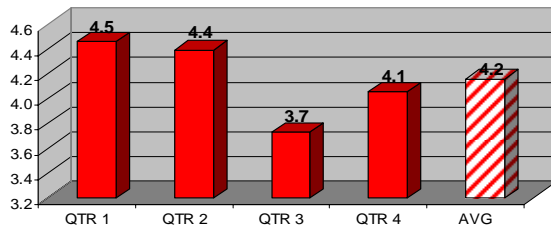

Total Schedule 70 Quarterly Sales FY07 (\$Billions)

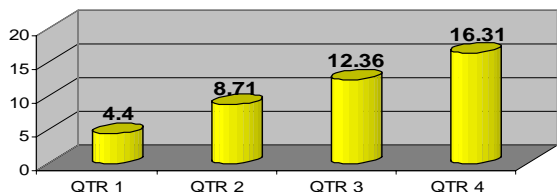


Difference in Quarterly Sales-Total Sales FY07 (\$Billions)

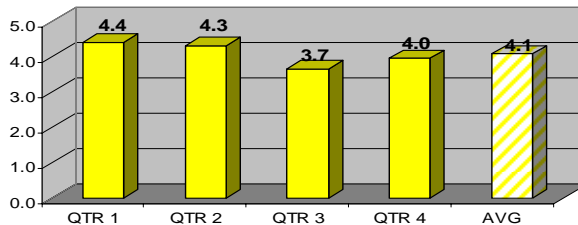


Federal Quarterly Sales

Federal Schedule 70 Quarterly Sales FY07 (\$Billions)

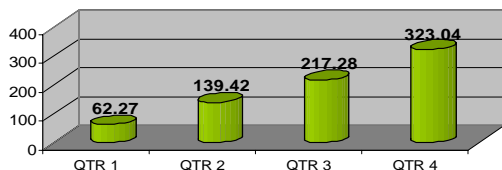


Difference in Quarterly Sales-Federal FY07 (\$Billions)

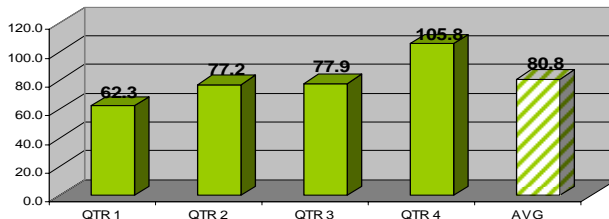


Cooperative Purchasing Quarterly Sales

State/Local Quarterly Sales FY07 (\$Millions)

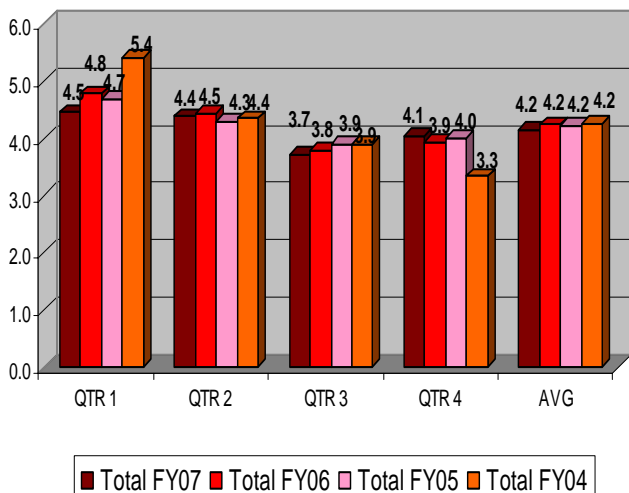


Difference in Quarterly Sales-State/Local FY07 (\$Millions)

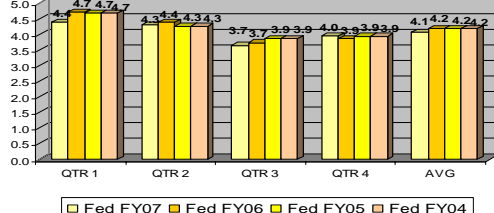

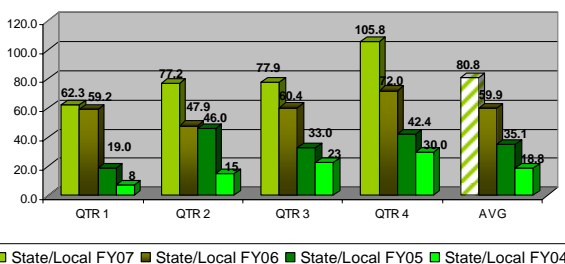
Difference in Quarterly Sales-Total Sch 70 -FY04 to FY07 (\$Billions)



Difference in Quarterly Sales-Federal Sch 70 FY04 to FY07 (\$Billions)



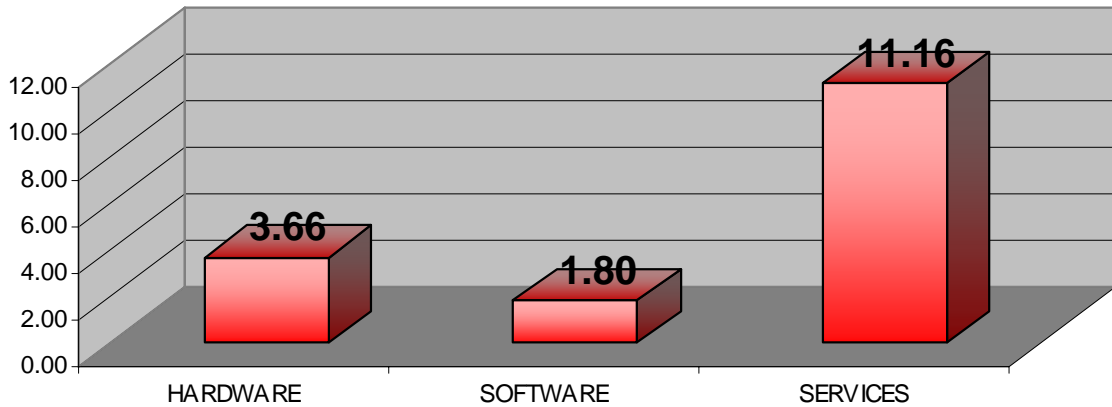
Difference in Quarterly Sales-State/Local - Sch 70 FY04 to FY07 (\$Millions)



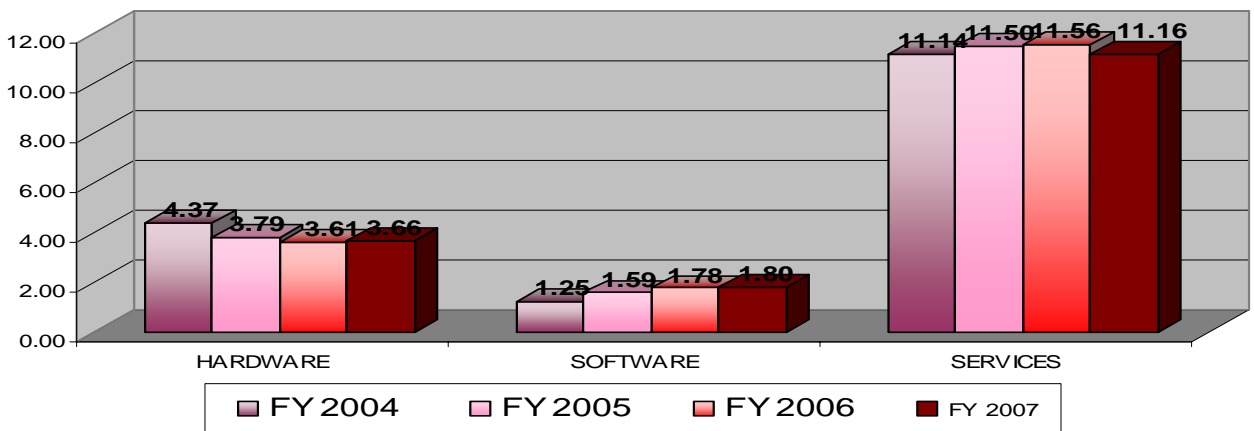

Total IT Schedule 70 Sales FY07 Breakdown (\$Billions)

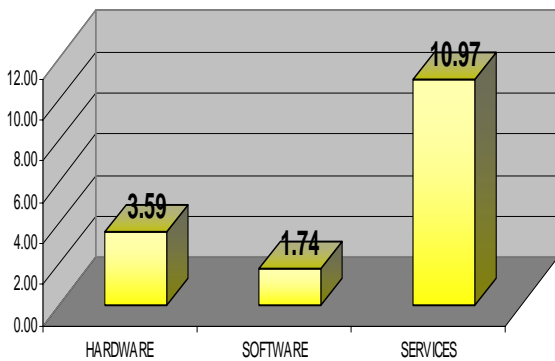


Total IT Schedule 70 Sales FY04 to FY07 Breakdown (\$Billions)

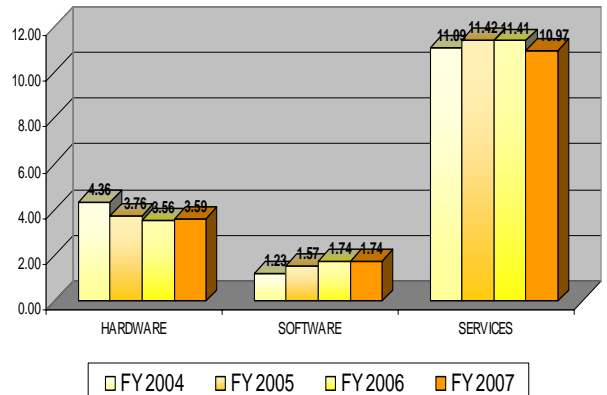


Federal IT Schedule 70 comparisons

Federal IT Schedule 70 FY07 Sales Breakdown (\$Billions)



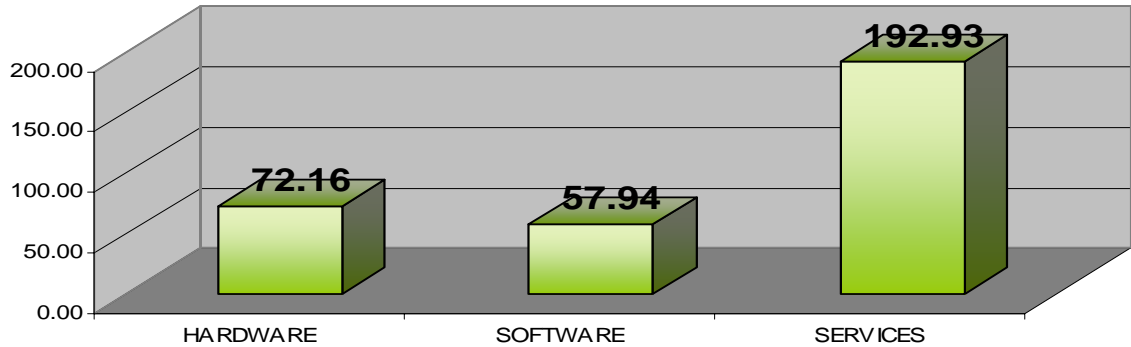
Federal IT Schedule 70 Sales FY04 to FY07 Breakdown (\$Billions)



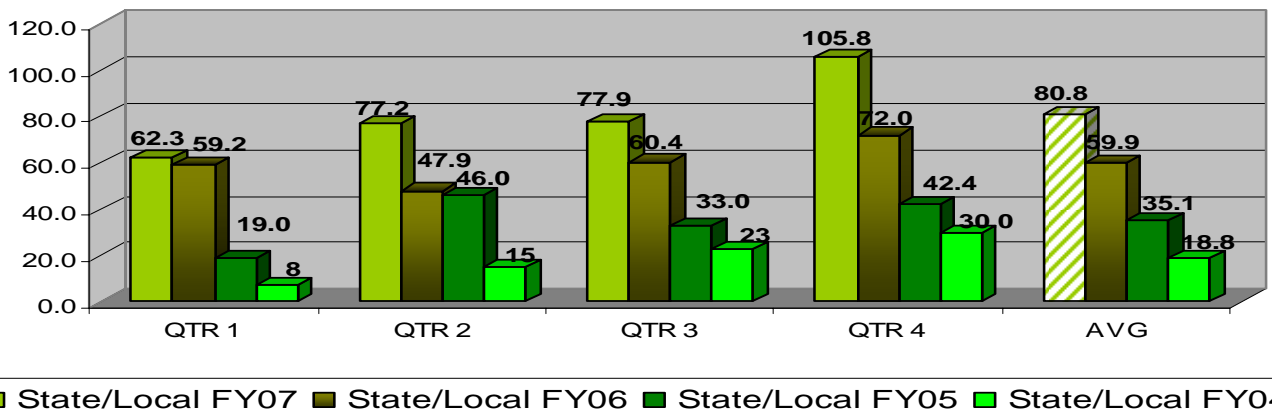

FY07 Sales Breakdown (\$Millions)**

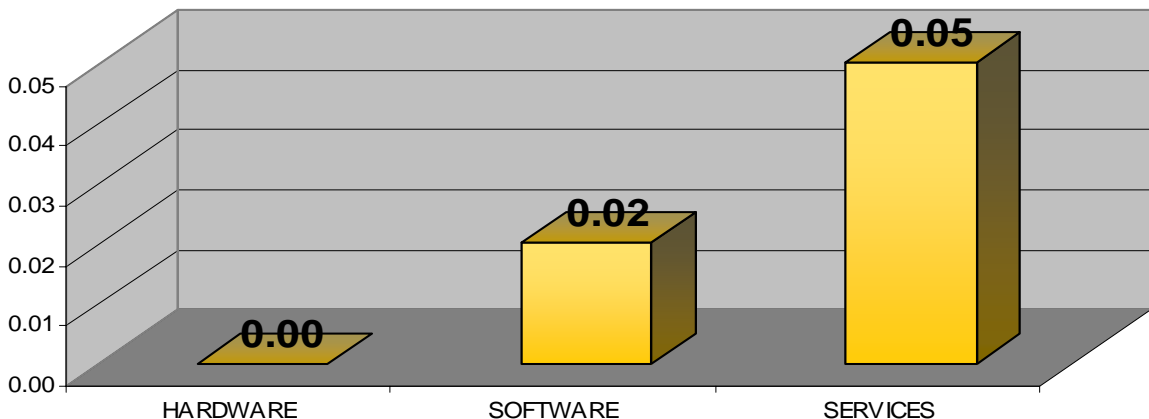


Difference in Quarterly Sales-State/Local- Sch 70 FY04 to FY07 (\$Millions)



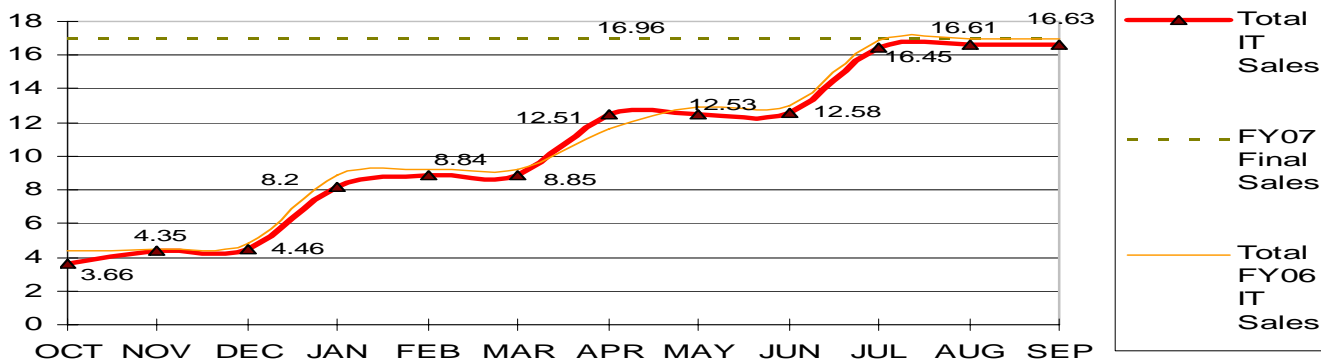
Disaster Recovery Breakdown

833- Disaster Recovery Purchasing -IT Schedule 70 Sales FY07 Breakdown (\$Millions)

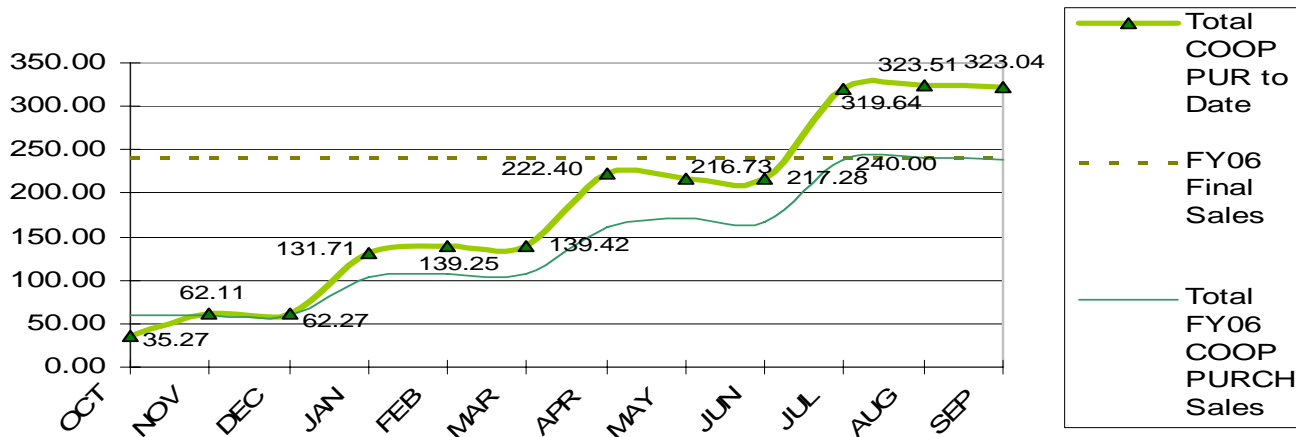


Monthly IT Schedule 70 Sales

Total Monthly IT Sales FY07 (in Billions)

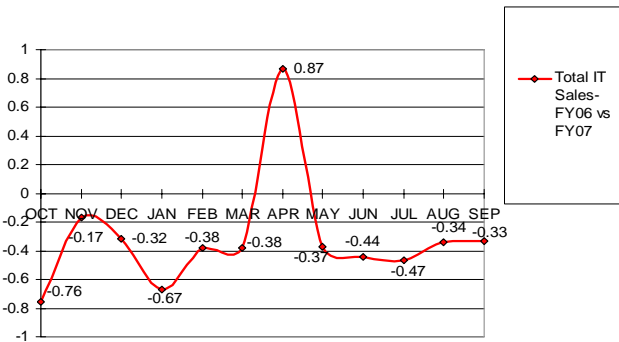


Total Monthly Cooperative Purchasing Sales FY07 (in Millions)

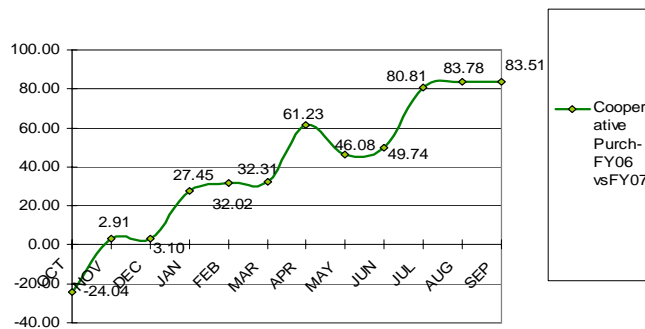

Monthly Comparison of Difference from FY06 to FY07 - Total IT Sales Schedule 70 (in Billions \$)



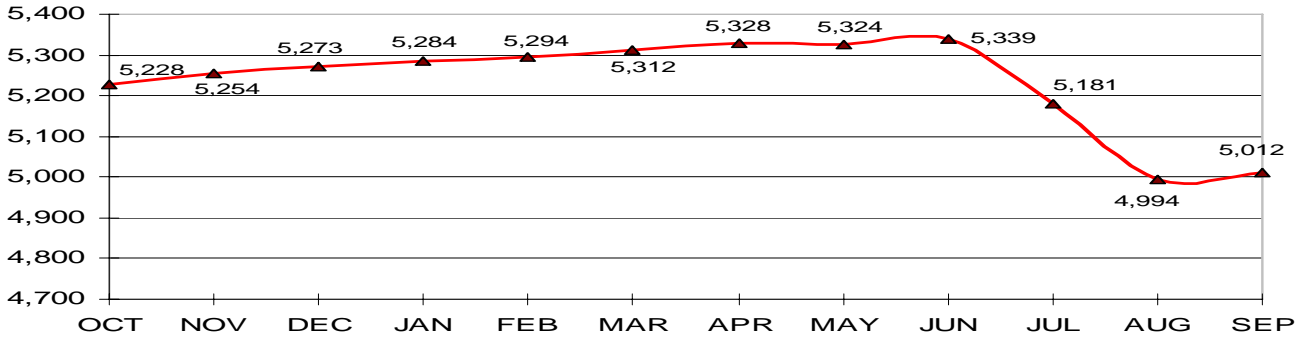
Monthly Comparison of Difference from FY06 to FY07 - Cooperative Purchasing IT Sales Schedule 70 (in Millions \$)



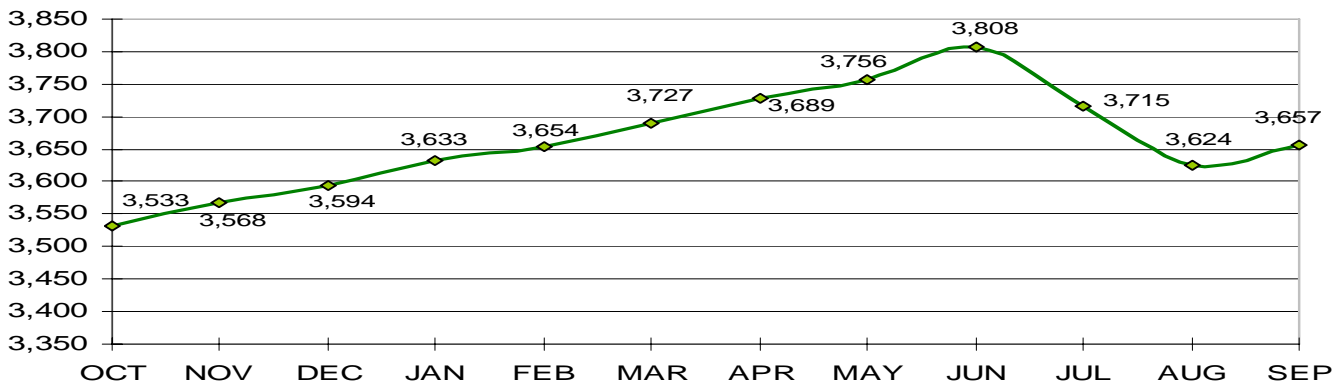

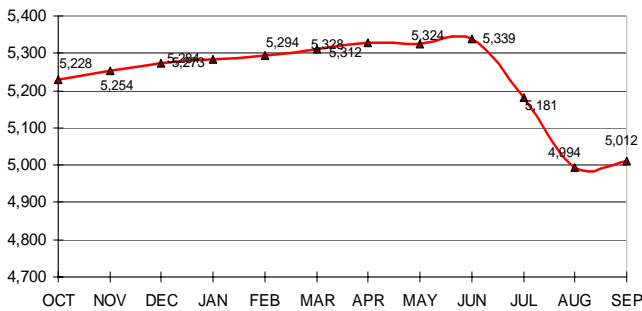
