

FERC-567 also contains valuable information that can be used to assist federal officials in maintaining adequate natural gas service in times of national emergency. The Commission implements these filing requirements in the Code of Federal Regulations (CFR) under 18 CFR 260.8 and 284.13.

5. *Respondent Description*: The respondent universe currently comprises 91 companies (on average) subject to the Commission's jurisdiction.

6. *Estimated Burden*: 12,724 total hours, 91 respondents (average), 1.714 responses per respondent (derived by dividing the total number of responses expected annually (156) by the number of respondents (91) and rounding to three places), and 81.58 hours per response (average).

7. *Estimated Cost Burden to respondents*: 12,724 hours/2080 hours per years × \$112,767 per year = \$689,830. The cost per respondent is equal to \$7,580.
