authorized to issue ISM Code certificates for the U.S.

*Abstract:* This information helps to determine whether U.S. vessels, subject to International Convention for the Safety of Life at Sea (SOLAS) 74, engaged in international trade, are in compliance with that treaty. Organizations recognized by the Coast Guard conduct ongoing audits of vessels' and companies' safety management systems.

*Burden Estimate:* The estimated burden has increased from 8,440 hours to 12,676 hours a year.
