We the undersigned are members of Local Union 1638 which is the bargaining unit for Consol's McElroy Coal Company.

This petition is addressed to Richard Harris of the McElroy Coal Company; Cecil Roberts of the United Mine Workers of America; Jim Dean of the West Virginia Office of Miners Health, Safety and Training; and David Dye of the Mine Safety and Health Administration.

We work in the most populous underground coal operation in the nation and represent in excess of 12,000 years of collective exposure to - and survival in the coal industry.

For several decades we have functioned without notable incident with an approved Ocenco SCSR storage plan. As with any plan, effectiveness is consummate with employee acceptance and training. The Ocenco storage plan criterion is no stranger to our workforce.

Sago miners died while using the CSE-100 SCSR. We all know the limitations assigned to the device. Recent history permits no room for debate on the issue.

Now, on the heels of the Sago disaster, West Virginia Governor Manchin and his surrogates come forth with a knee jerk plan to un-ring the bell at Sago.

Davitt McAteer, per his appointment by Joe Manchin as special investigator into the Sago disaster, has elected to jump start the Ocenco witch hunt he began over half a decade earlier.

McAteer's cheerleading in favor of eliminating the Ocenco SCSR storage plan was poor judgment years ago. Sago is recent proof. Can his argument be more convoluted?

Don't permit the arrogance of the very few to usurp the wisdom of 12,000 years experience *in toto*.

We, the petitioners, request the preservation of the existing Ocenco SCSR storage plan at the McElroy Coal Mine.
