ADVISORY

IF YOU ARE A HOLDER OF AN EXEMPTION THAT AUTHORIZES THE USE OF A PACKAGING WITH A MAXIMUM CAPACITY LESS THAN 450 L (119 GALLONS) OR A MAXIMUM NET MASS LESS THAN 400 KG (882 POUNDS), PLEASE BE ADVISED THAT YOUR EXEMPTION MAY NOT BE RENEWED BEYOND SEPTEMBER 30, 1996. IN ADDITION, NO NEW CONSTRUCTION OF PACKAGINGS WHICH FALL WITHIN THE NON-BULK CAPACITIES LISTED ABOVE ARE AUTHORIZED AFTER SEPTEMBER 30, 1994. THIS IS CONSISTENT WITH THE IMPLEMENTATION OF THE NEW PACKAGING REQUIREMENTS ADOPTED UNDER DOCKET HM-181. ANY APPLICATION SUBMITTED TO THIS OFFICE TO RENEW AN EXEMPTION BEYOND THE SEPTEMBER 30, 1996 DATE WILL BE DENIED UNLESS THE APPLICATION CONTAINS SUPPORTING INFORMATION TO JUSTIFY THE CONTINUATION OF THE EXEMPTION.

- 1. <u>GRANTEE:</u> Canadian Pacific Limited, CP Rail Division Montreal, Quebec, Canada (U. S. Agent: CP Rail Systems Legal Services, Minneapolis, MN.)
- 2. <u>PURPOSE AND LIMITATION:</u> This exemption authorizes those Canadian based employees of CP Rail, who are engaged in infrequent and limited transportation of hazardous materials into the United States, to be trained and receive recurrent training every three years in accordance with Part 9 of the Transportation of Dangerous Goods (TGD) Regulations in place of the training, and two-year recurrent training, requirements of 49 CFR Part 172, Subpart H. This exemption provides no relief from any regulation other than as specifically stated.
- 3. <u>REGULATORY SYSTEM AFFECTED:</u> 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED:</u> 49 CFR Section 172.704(c)(2).
- 5. <u>BASIS</u>. This exemption is based on CP Rail's application dated May 12, 1995, submitted in accordance with 49 CFR 107.105.
- 6. <u>HAZARDOUS MATERIALS (49 CFR 172.101):</u> Any, as authorized for transportation by railroad.
- 7. SAFETY CONTROL MEASURES: This exemption is limited to those employees of CP Rail who have been trained in conformance with Part 9 of the TDG Regulations. Operations using such employees are limited to direct movements between the United States/Canada border to terminals located in:

Sumas, Washington; Kingsgate, Idaho; Coutts, Montana; North Portal, North Dakota; Emerson, Minnesota; Detroit, Michigan Niagara Falls, New York; Buffalo, New York, or Newport, Vermont. 8. <u>SPECIAL PROVISIONS</u>. A copy of this exemption, in its current status, must be maintained at each terminal identified in Paragraph 7 above and must be made available to a DOT representative upon request.

MODES OF TRANSPORTATION AUTHORIZED. Rail freight.

- 10. MODAL REQUIREMENTS: Not as a condition of this exemption.
- 11. <u>COMPLIANCE</u>. Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials law, 49 U.S.C. Section 5101 <u>et. seq.</u>,
 - o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Any use or application of this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect unless a regulation has been amended making the exemption no longer necessary.
 - o Registration required by 49 CFR 107.601 <u>et seq.</u>, when applicable.
- 12. <u>REPORTING REQUIREMENTS</u>. Not as a condition of the exemption.
