1. GRANTEE: Westvaco Corporation, New York, New York.
2. PURPOSE AND LIMITATION: This emergency exemption authorizes the shipment of a DOT Specification 105A500W tank car, containing a Division 2.3 material, meeting all DOT requirements except that the tank car has a defective safety relief valve and chlorine "C" kit attached. This exemption provides no relief from any regulations other than as specifically stated.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR 173.29(c)(2); 173.31(b)(3); 179.100-12(c); and 179.100-13.
5. BASIS. This emergency exemption is based on Westvaco Corporation's application of August 4, 1993, submitted in accordance with 49 CFR 107.113, and a determination that it is necessary for the protection of life and property and supplemental letter dated October 18, 1993.
6. HAZARDOUS MATERIALS (49 CFR 172.101):

7. PACKAGING(S) and SAFETY CONTROL MEASURES:
  - a. PACKAGING - Packaging prescribed is a DOT Specification 105A500W tank car, GATX 2419, with a defective safety relief valve. The tank car has been equipped with a chlorine "C" kit to prevent the emission of sulfur dioxide vapors.
  - b. TESTING - The safety relief valve for tank car GATX 2419 must be retested prior to the tank car being refilled.

c. MARKING - Tank car GATX 2419 must be marked "DOT-E 11095" in four inch letters on a contrasting background above the DOT specification number.

d. The manway protective housing cover, while opened, must be chained or otherwise fastened so that it cannot change position during transportation.

8. SPECIAL PROVISIONS.

a. Shipment of tank car GATX 2419 is authorized from CSX Transportation, Tilford Yard, Atlanta, Georgia, to Empak, Fitzgerald, Georgia, a distance of approximately 207 miles utilizing the most direct route via CSX Transportation.

b. Persons who receive packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with, and a current copy of this exemption is maintained at each facility from which such reoffering occurs.

9. MODES OF TRANSPORTATION AUTHORIZED. Rail freight.

10. MODAL REQUIREMENTS: Not as a condition of this exemption.

11. COMPLIANCE. Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Hazardous Materials Transportation Act:

- All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, Parts 171-180.
- Any use or application of this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect unless a regulation has been amended making the exemption no longer necessary.
- Registration required by 49 CFR 107.601 et seq., when applicable.

12. REPORTING REQUIREMENTS.

a. The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.)
