1. GRANTEE:

- a. Persons represented by the Alliance Petroleum Corporation (APC), Danville, CA
- b. Persons represented by the California Independent Oil Marketers Association (CIOMA), West Sacramento, CA.

(See Appendix A of this exemption for a list of members)

2. PURPOSE AND LIMITATION: This exemption authorizes the continued intrastate transportation of certain Class 3 liquids in non-DOT specification cargo tanks whose designs have been approved by the California State Fire Marshall and were placed into service prior to April 1, 1984. These cargo tanks may be certified and marked as DOT Specification 306 cargo tank motor vehicles prior to August 31, 1996. This exemption provides no relief from any regulation other than as specifically stated herein.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: The certification date specified in 49 CFR 180.405(b) for MC 306 cargo tanks, 180.405(g)(2), 180.405(g)(3), and the date by which the first test must be completed in the Table in 180.407(c).
5. BASIS: This exemption is based on the application submitted on behalf of APC and CIOMA dated July 14, 1995, and additional information dated August 3, 1995, submitted in accordance with 49 CFR 107.103 and the public proceeding thereon.

6. HAZARDOUS MATERIALS (49 CFR 172.101):

7. PACKAGING AND SAFETY CONTROL MEASURES:

- a. PACKAGING - Packagings prescribed are non-DOT specification cargo tank motor vehicles designed, manufactured and certified in conformance with the California State Fire Marshall regulations contained in Title 19 California Code of Regulations (California Code). Cargo tank manhole assemblies on the subject tanks must meet the requirements contained in 49 CFR 180.405(g) by August 31, 1996.
- b. TESTING - Each cargo tank motor vehicle must be tested and inspected as required for a DOT Specification MC 306 cargo tank motor vehicle in 49 CFR 180.407(c) no later than August 31, 1996.
- c. MARKING
 - (1) Prior to marking a California Code certified cargo tank motor vehicle as a DOT Specification MC 306, a registered inspector, a registered cargo tank manufacturer or a registered repair facility must certify that the cargo tank motor vehicle meets the requirements of the California Code.
 - (2) Each cargo tank must be marked "DOT-E 11509 CALIFORNIA ONLY" in letters at least two inches in height on a contrasting background, on both sides of the tank near the front on a location as close as practicable to the horizontal centerline.

8. SPECIAL PROVISIONS:

a. A cargo tank covered by the terms of this exemption may only be operated in intrastate commerce within the State of California by an intrastate motor carrier.

b. Each cargo tank covered by the terms of this exemption must have been in service prior to April 1, 1984.

c. A Cargo tank manufactured prior to September 1, 1967 is only authorized for continued use subject to the approval and conditions specified by the California Highway Patrol.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.10. MODAL REQUIREMENTS: A copy of this exemption must be carried aboard each motor vehicle.11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law 49 U.S.C. Section 5101 et seq:

- o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
- o Registration required by 49 CFR 107.601 et seq., when applicable.


No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect.

12. REPORTING REQUIREMENTS:

a. The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incidents involving the package and shipments made under the terms of this exemption.

b. Grantees must provide the Office of Hazardous Materials Exemptions and Approvals with quarterly reports which state how many cargo tank motor vehicles have been certified and marked as DOT specification cargo tank motor vehicles.
