- 1. <u>GRANTEE:</u> Union Pacific Railroad Company Omaha, Nebraska
- 2. <u>PURPOSE AND LIMITATION:</u> This emergency exemption authorizes the transportation, in commerce, of a DOT Specification 105A500W tank car, containing a division 2.3 material, meeting all DOT requirements except that the tank car has a defective safety relief valve with a chlorine "C" kit attached. This exemption provides no relief from any regulations other than as specifically stated.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR 173.31(a); 173.24(b); 179.100-15(c); 179.100-12(c); 174.3; 174.50(a); 172.302(c); and provision (1) of the paragraph entitled Packages. Containers. Shipments of Appendix B to Subpart B of Part 107.
- 5. <u>BASIS.</u> This emergency exemption is based on Union Pacific Railroad Company's application of January 10, 1996, submitted in accordance with 49 CFR 107.113, and a determination that it is necessary for the protection of life and property.

# PACKAGING(S) and SAFETY CONTROL MEASURES:

- a. <u>PACKAGING</u> Packaging prescribed is a DOT specification 105A500W tank car, GATX 45259, meeting all DOT specification requirements except that the tank car has a defective safety relief device. A Chlorine "C" Kit has been installed to prevent the release of product.
- b. <u>MARKING</u> The marking requirements specified in 172.302(c) and provision (1) of the paragraph entitled <u>Packages</u>, <u>Containers</u>, <u>Shipments</u> of Appendix B to Subpart B of Part 107 are waived.

## 8. SPECIAL PROVISIONS.

- a. Shipment of tank car GATX 45259 is authorized from Boise Cascade Paper Company, Wallula, Washington, to Weyerhaeuser Company, Columbia Junction, Washington, a distance of approximately 300 miles utilizing the most direct route available via Union Pacific Railroad Company.
- b. The protective housing cover for tank car GATX 45259 shall be secured in the open position to prevent movement.
- 9. <u>MODES OF TRANSPORTATION AUTHORIZED.</u> Rail freight.

#### MODAL REQUIREMENTS:

- 11. <u>COMPLIANCE</u>. Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by Federal hazardous materials transportation law, 49 U.S.C. Section 5101 <u>et seq</u>:
  - All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.

Registration required by 49 CFR 107.601 et seq., when applicable.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect.

## 12. REPORTING REQUIREMENTS.

a. The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder of this exemption must inform the AAHMS, in writing, of any incident involving the package and shipment made under the terms of this exemption.
