1. <u>GRANTEE</u>: Williams Field Services Opal, WY

### 2. PURPOSE AND LIMITATION:

a. This special permit authorizes attendants of a cargo tank loading facility to remain in a warming shack during loading operations which is not within the required 25 feet from the cargo tank. This special permit only applies to loading or unloading operations meeting the definition of "loading incidental to movement" or "unloading incidental to movement" as those terms are defined in § 171.8 of the Hazardous Materials Regulations (HMR). This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.

b. The safety analyses performed in development of this special permit only considered the hazards and risks associated with transportation in commerce.

c. No party status will be granted to this special permit.

- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR § 177.834(i)(3) in that the loading or unloading of a cargo tank without the attendance of a qualified person within 25 feet of the cargo tank is not authorized, except as specified herein.
- 5. <u>BASIS</u>: This special permit is based on the application of Williams Field Services dated May 24, 2006, submitted in accordance with § 107.109.

#### 7. SAFETY CONTROL MEASURES:

- a. <u>PACKAGING</u> Prescribed packagings are DOT Specification cargo tanks authorized to transport gasoline and liquefied petroleum gas.
- b. OPERATIONAL CONTROLS -

(1) There must be an emergency shutdown switch for the loading rack by the front door of the warming shack.

(2) The warming shack must have windows in order for the drivers to see the loading rack and the truck with an unobstructed view.

(3) The loading operations must be monitored via television camera from a control center 1/4 mile from the loading rack. The control room is manned 24 hours a day, 7 days a week, and contains an emergency shutdown for the rack.

(4) Each attendant at the automated truck loading facility must be trained in emergency procedures that must be followed in the event that both emergency shutdown switches in the warming shack and in the control room fail.

#### 8. SPECIAL PROVISIONS:

- a. This special permit applies only to loading incidental to movement or unloading incident to movement at the Williams Field Services Opal plant at 1 Mile West Highway 30, Opal, WY, 83124.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.

- 10. <u>MODAL REQUIREMENTS</u>: None as a requirement of this special permit.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et</u> seq:
  - All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
  - Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
  - o Registration required by § 107.601  $\underline{\text{et seq.}}$ , when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)- 'The Hazardous Materials Safety and Security Reauthorization Act of 2005' (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term 'exemption' to 'special permit' and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. <u>REPORTING REQUIREMENTS:</u> Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator Continuation of DOT-SP 11839 (5<sup>th</sup> Rev.)
