DOT-E 10465

- 1. Stonhard, Inc., Maple Shade, New Jersey, is hereby granted an exemption from certain provisions of this Department's Hazardous Materials Regulations to offer packages prescribed herein of a corrosive material, corrosive to skin only, for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes the shipment of a corrosive liquid mixture containing N-Aminoethylpiperizine, classed as a corrosive material, in an unlined 28/26 gauge DOT Specification 37C80 steel drum of five gallon capacity, and provides no relief from any regulation other than as specifically stated.
- 2. <u>BASIS</u>. This exemption is based on Stonhard, Inc.'s application dated August 20, 1990, submitted in accordance with 49 CFR 107.103 and the public proceeding thereon.
- 3. <u>HAZARDOUS MATERIALS (Descriptor and class)</u>. A liquid mixture containing N-Aminoethylpiperizine, classed as a corrosive material.
- 4. PROPER SHIPPING NAME (49 CFR 172.101). Corrosive liquid, n.o.s.
- 5. REGULATION AFFECTED. 49 CFR 173.245.
- 6. MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle.
- 7. <u>SAFETY CONTROL MEASURES</u>. Packaging prescribed is an unlined DOT Specification 37C80 steel drum, with a minimum thickness of 0.0129 inch in the body of the drum, and 0.0159 inch in the removable top head of the drum.

8. <u>SPECIAL PROVISIONS</u>.

- a. Persons who receive packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with and a current copy of this exemption is maintained at each facility from which such reoffering occurs.
- b. Drivers must have been instructed as to necessary safeguards and proper procedure in the event of unusual delay, fire, or accident.

- c. Each drum body and cover or lid must be plainly and durably marked "DOT-E 10465."
- 9. <u>REPORTING REQUIREMENTS</u>. Any incident involving loss of packaging contents or packaging failure must be reported to the Associate Administrator for Hazardous Materials Safety as soon as practicable.
- 10. EXPIRATION DATE. November 30, 1992.
