DOT-E 10881  
(FIRST REVISION)

1. The TACC International Corporation, Rockland, MA., is hereby granted an emergency exemption from certain provisions of this Department's Hazardous Materials Regulations to offer packages prescribed herein of a flammable liquid for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes the shipment of an adhesive, with a flash point of less than 0°F, classed as a flammable liquid, contained in DOT Specification 37C drums of 5 gallons capacity and provides no relief from any regulation other than as specifically stated. NOTE: Reference to 49 CFR sections in this exemption are to regulations in effect on September 30, 1990.

2. BASIS. This exemption is base on TACC International Corporation's application dated September 3, 1992 and supplemental letter dated February 9, 1993, submitted in accordance with 49 CFR 107.113 and a determination that it is necessary to preclude serious economic loss.

3. HAZARDOUS MATERIALS (Descriptor and class). Adhesive, with a flash point of less than 0°F., classed as a flammable liquid, UN 1133.

4. PROPER SHIPPING NAME (49 CFR 172.101). Adhesive.

5. REGULATION(S) AFFECTED. 49 CFR 173.32.

6. MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle.

7. SAFETY CONTROL MEASURES. Packaging prescribed is a DOT Specification 37C drum of 5 gallons capacity.

8. SPECIAL PROVISIONS.

a. Persons who receive packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with and a current copy of this exemption is maintained at each facility from which such reoffering occurs.

b. A copy of this exemption must be carried aboard each motor vehicle used to transport packages covered by this exemption.

c. The outside of each drum must be plainly and durably marked "DOT-E 10881."

9. REPORTING REQUIREMENTS. Any incident involving loss of packaging contents or packaging failure must be reported to the Associate Administrator for Hazardous Materials Safety as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.)

10. EXPIRATION DATE. August 31, 1993, or upon depletion of the existing stock of drums, whichever occurs earlier.
