# DOT-SP 10921 (SEVENTH REVISION)

(FOR RENEWAL, SEE 49 CFR § 107.109)

- 1. GRANTEE: (See individual authorization letter)
- 2. PURPOSE AND LIMITATION:
  - a. This special permit authorizes the transport in commerce of certain flammable liquids, described in paragraph 6, packaged in combination packagings. Packages transported in accordance with this special permit are not subject to the Hazardous Materials Regulations (HMR) except as provided herein.
  - b. The safety analyses performed in development of this special permit considered only the hazards and risks associated with transportation in commerce.
  - c. Unless otherwise stated herein, this special permit consists of the special permit authorization letter issued to the grantee together with this document.
- 3. REGULATION SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR Parts 171-180, except as specified in this special permit.
- 5. <u>BASIS</u>: This special permit is based on the application of Procter & Gamble Company dated February 23, 2006 submitted in accordance with § 107.109.

## 6. HAZARDOUS MATERIALS (49 CFR 172.101):

Materials are beverages, foods, cosmetics and medicines, and concentrates used therein, in aqueous solutions containing not more than 70% ethyl alcohol by volume. These materials meet the definition of a flammable liquid, Class 3, PG II or III and may not meet the criteria of any other hazard class. No proper shipping name is required.	N/A	N/A	N/A

### 7. SAFETY CONTROL MEASURES:

- a. <a href="PACKAGING">PACKAGING</a> Materials listed in paragraph 6 must be packaged in combination packagings as follows:
  - (1) Inner packagings. Inner packagings must be polyethylene, or other non-brittle plastic, bottles and may not be over 1.5 L (50 fluid ounces) net capacity each. Glass inner packagings are not authorized.
  - (2) Outer packagings. Inner packagings must be packed in strong outer packagings. The total contents in each outer package may not exceed 9.0 L (300 fluid ounces).

#### b. OPERATIONAL CONTROLS -

- (1) Each Packaging must conform to the provisions of §§ 173.24 and 173.24a.
- (2) Each completed outer packaging may not exceed 11 kg (24 pounds) gross weight each.
- (3) Packages must be marked with package orientation markings on two opposite vertical sides with arrows pointing in the correct upright position.

## 8. SPECIAL PROVISIONS:

- a. The outside of each package authorized by this special permit must be plainly and durably marked with "DOT-SP 10921" in letters at least one-half inch high on a contrasting background.
- b. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modifications or changes are made to the package and it is reoffered for transportation in conformance with this special permit and the HMR.
- c. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.
- d. Packagings permanently marked 'DOT-E 10921', prior to October 1, 2007 may continue to be used under this special permit for the remaining service life of the packaging or until the special permit is no longer valid. Packagings marked on or after October 1, 2007 must be marked 'DOT-SP 10921'.
- e. Shipping papers displaying 'DOT-E 10921' may continue to be used until October 1, 2007, provided the special permit remains valid.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.
- 10. MODAL REQUIREMENTS: None as a requirement of this special permit.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et</u> seq:
  - o All terms and conditions prescribed in this special permit and the HMR, 49 CFR Parts 171-180.
  - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.

o Registration required by § 107.601 et seq., when applicable.

No person may use or apply this special permit, including display of its number, when the special permit has expired or is otherwise no longer in effect unless a regulation has been amended making the special permit no longer necessary.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)- 'The Hazardous Materials Safety and Security Reauthorization Act of 2005' (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term 'exemption' to 'special permit' and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
