### Appendix 8: Census 2000 Industry Categories for the Special EEO Tabulation

The complete Census 2000 Industry Classification System consists of 265 detailed categories, including seven Armed Forces categories. Because of concerns that the cross-classification of small industries with multiple occupations might lead to the disclosure of information about individual respondents in the census, the Census Bureau decided to publish data for individual industries in the 1997 North American Industry Classification System (NAICS) that were aggregated to the three-digit subsector level. In some instances the industries were aggregated either to the 1997 NAICS two-digit sector level or combined with more than one subsector. Also, there are two categories where the industry aggregates cross subsectors. As a result 88 industry categories are shown for the Census 2000 Special EEO Tabulation. This list provides for each industry category both the three-digit census code and the equivalent 1997 NAICS sector or subsector code.
