- FY 2008 FCSS Scheduling Cycle: 10/1/07 – 9/30/08
- First Release Fall 2007
- Second Release March 2008
  - 5000 establishments
  - Revised CSALs mailed
- Updated website FAQs regarding scheduling process






#### Office of Federal Contract Compliance Programs HOW TO CONFIRM WHETHER YOUR COMPANY WAS MAILED A CSAL

- CSALs mailed to CEO of each parent company with 2 or more establishments on the scheduling lists issued in a scheduling cycle
- Confirm receipt by faxing a written request on company letterhead to:

Division of Policy, Planning & Program Development 202-693-1304 (not a toll-free number)





### VEVRAA REGULATORY CHANGES

- New 60-300 regulations
  - Revised Categories of Protected Veterans
  - New Mandatory Listing Requirement
  - Effective Date
- Vets 100 & Voluntary Self-Identification Requirements
- Updates to 60-250 regulations

### HOW TO OBTAIN RECORDS FROM AMERICA'S JOB BANK

- To retrieve job posting records from AJB:
  (1) <u>www.jobbankinfo.org</u> and follow prompts
  (2) send an email to <u>ajb@labor.state.ny.us</u>
- Records are available for limited time do not wait until scheduled compliance evaluation

### COMPENSATION DISCRIMINATION

- New Director of Division of Statistical Analyses
  - Expect to hire several additional statisticians in FY 2008
- Desk Audit of Contractor's Compensation Data
  - Developed consistent internal procedures for evaluation
  - Focus on access to data





### ACCESSIBILITY OF ONLINE APPLICATION SYSTEMS


- Inter-agency workgroup
