Metro/Driving Directions

From Metro: Take either the Yellow or Blue line to the Crystal City Station

Indoor walking route: From the Metro take the main escalators up one level and go through the glass doors on your left into the concourse. Follow this concourse up a flight of stairs, at the Northern Virginia Doctors of Optometry jog to the left and immediately right, proceed straight passing the beautician, barber shop and entrance to the Crystal City Marriott Hotel until you arrive at the wall mural. At this point veer to the left and proceed until the next intersection, turn right at Au Bon Pan. At the next intersection, by Rite Aid veer right and go left around the spiral stairs. Proceed straight to the next spiral stairs, by McDonald's. After passing the stairs, go left towards the 2200 Crystal Drive exit. Walk towards the exit doors and immediately on your right will be a recessed elevator lobby. Either of these two elevators will take you to the main lobby of the building. Once you are at the main lobby level you will need to follow FAS security procedures to your final destination.

Outdoor walking route: Take the main escalators up two levels until you are above ground. Turn left to walk down 18th Street. 18th Street will end at Crystal Drive. Turn right on Crystal Drive and walk down to 20th Street, cross 20th street at McCormick and Schmick's Seafood, proceed under the overhead walkway to the 2200 Crystal Drive entrance into the building. Once inside, walk just past Coldstone Creamery to a recessed elevator lobby. Either of these two elevators will take you to the main lobby of the building. Once you are at the main lobby level you will need to follow FAS security procedures to your final destination.

Driving Directions:

From I-66:

Take I-66 towards Washington. After you pass the signs for Rosslyn/Key Bridge, take Exit 75-Route 1/Alexandria. Follow the signs for Route 1 South/Alexandria. Once on Route 1, turn left onto 23rd Street. 23rd Street will end in one block at Crystal Drive.

At this intersection, make a left turn onto Crystal Drive and make a left turn into 2200 Crystal Drive.

From DC:

Take the 14th Street Bridge over the Potomac River and take the Crystal City/Route 1 exit. Stay on Route 1, turn left on 23rd Street, which will end at 2345 Crystal Drive.

At this intersection, make a left turn onto Crystal Drive and make a left turn into 2200 Crystal Drive.

From Virginia:

Take 495 or 95 to 395 North. Take Exit 7A-Glebe Road South. Follow Glebe Road until it dead ends into Route1. Turn left onto Route 1. Turn right onto 23rd Street at the light. 23rd Street will end in one block at Crystal Drive.

At this intersection, make a left turn onto Crystal Drive and make a left turn into 2200 Crystal Drive.

From Reagan National Airport (DCA):

Take Return to Airport/GW Parkway South Exit, continue on Abingdon Drive towards Crystal City (US-1)/Remote Parking (I-66)/General Aviation/Airport Services. Turn on VA-233 towards US-1/I-66/Crystal City. Take Crystal Drive Exit. Follow to 23rd Street.

At this intersection, make a left turn onto Crystal Drive and make a left turn into 2200 Crystal Drive.

From Maryland:

Take 495 towards Virginia. After going over the Woodrow Wilson Bridge, take Exit 1. Follow the signs for Route 1 North and Arlington/Old Town Alexandria. Follow Route 1 for about 10 minutes. Turn right onto 23rd Street at the light. 23rd Street will end in one block.

At this intersection, make a left turn onto Crystal Drive and make a left turn into 2200 Crystal Drive.

From Montgomery County via 495 exit to George Washington Parkway:

Exit at Ronald Reagan Airport, Take Return to Airport/GW Parkway South Exit, continue on Abingdon Drive towards Crystal City (US-1)/Remote Parking (I-66)/General Aviation/Airport Services. Turn on VA-233 towards US-1/I-66/Crystal City. Take Crystal Drive Exit. Follow to 23rd Street.

At this intersection, make a left turn onto Crystal Drive and make a left turn into 2200 Crystal Drive.

Building Access

From the garage, enter the building via the Shuttle elevators for 2200 Crystal Drive located just to the right of the garage entrance for 2200 Crystal Drive. Take the Shuttle Elevator to the Lobby level. Exit the elevator and proceed in accordance with FAS security procedures.

You may also take the elevator under any of the six office buildings (except 220 S. 20th Street) to the Shops Level and proceed through the Shops Level to the Shuttle elevators for 2200 Crystal Drive. These Shuttle elevators are located by Coldstone Creamery and Corner Bakery Cafe.

Garage Hours of Operation:

Garage is available 24/7 with a parking card. Additionally, from 4pm until 5am each weekday and 24/7 on Saturday and Sunday the gates are open for public parking for customers of the Crystal City Retail.

The parking garage is managed by PMI, Inc. PMI's new Customer Service Center on-site office is located on the G1 (retail) level between 2100 Crystal Drive and 220 20th Street. It is easily identified by a bright sign: PUBLIC PARKING. The hours of operation are 6am - 6pm, Monday thru Friday. The Customer Service telephone number is (703) 842-2971. Parking Spaces

There are handicapped and visitor parking spaces in this garage. FAS employees can park in any open space that is not Reserved, Handicapped or Visitor. FAS employees with a DMV issued HP permit may park in any Handicapped parking space.

Oversized Vehicle Parking

Vehicles with a clearance higher than 6'4" can utilize the G1 level parking lots accessible at 220 20th Street South and 223 23Rd Street South. The clearance for these two lots is 7'2".

If you lose your parking access card, please report it to the on-site PMI Office. There is a \$15.00 charge to replace a lost or broken card.
