The Committee on the Judiciary had referred to it 1,286 bills and resolutions during the 99th Congress. This represents 22% of the 5,743 bills and resolutions introduced in the U.S. House of Representatives for that Congress. Of this number, 957 were public bills and resolutions, and 329 were private bills and resolutions. A total of 59 which received consideration by the committee were enacted into public law, and no measures considered by the committee were enacted into private law.
